## YOUNG WORKER COMMITTEES

In some excellent news to start 2018, Young Worker Committees have officially been formed in Edmonton and in Winnipeg. In Edmonton, the first meeting took place Tuesday, January 16th; In Winnipeg, the first meeting was held Thursday, January 18th.

Workers from outside Winnipeg and Edmonton were encouraged to get involved by calling into one of the two meetings. Big thanks to the PRC Young Worker's Rep Mackenzie Campbell for all of her work in bringing this together.

## YOUNG WORKER SUMMIT

Planning has begun for our next Prairies Young Workers' Summit being held April 13-15, 2018 in Edmonton. All PSAC members in good standing age 35 and under are eligible to apply.

## **CBSA RALLY IN REGINA**

As CIU members await the PIC report, the rally served as a show of support for the bargaining team who has been at the table fighting for a fair collective agreement that includes recognition of CBSA Officers as law enforcement. Thank you to everyone who came out to show their solidarity and to fight for a fair deal, including: CIU Saskatchewan Local 40031, PSAC Regina Area Council, PSAC Local 40005, USGE, UNE and CEIU.

We received a great deal of media attention for this rally, including an excellent story in the Leader-Post, Radio-Canada, and Minister Ralph Goodale's "response" to 620 CKRM.

Special thanks to Santa Claus (who reminds us an awful lot of CIU Sask. Branch 2nd VP and PSAC Prairie Region Young Worker's Alternate Rep Glenn Hollyoake), Santa's Chief Elf and the Gingerbread Man for stopping by to unveil Santa's Naughty and Nice List. No surprise to see PM Trudeau, MP Ralph Goodale, MP Scott Brisson and MP Bill Morneau on the naughty list. Topping out the nice list... President Robyn Benson, CIU President JP Fortin, the FB Bargaining Team and I made the Nice list!

## SUPPORT OUR PORT

In an unending legal battle, Omnitrax has declared its intention to sue the federal government under NAFTA rather than live up to its duty to repair the rail line.

Waiting for lawsuits and counter suits to solve this issue only means more delays, more devastation and more hardship for the people of Churchill. The time is now to bring the Port and the railway into public hands.

PSAC has consistently called on the federal government to bring the Port of Churchill and the rail line back as a national asset so that it can return to full operation in the short term, and remain so for generations to come. Similar to an airport authority, port authority status would allow community and government representatives to sit on the board and be accountable to various stakeholders, including municipalities and Indigenous communities, instead of being focused solely on corporate shareholders. The Minister of Transport has the authority under the Canada Marine Act to amend the list of regulated port authorities by Order in Council or regulation.

It is also urgent that the Province of Manitoba institute a fuel subsidy to offset the exorbitant gasoline prices that northern communities are facing, and sit down with all the partners in Churchill to help develop an economic plan that includes fixing the rail line and re-opening the valuable Port of Churchill for business again.

Unfortunately, despite the significant media and community attention this issue has received, the provincial government failed to even mention the community of Churchill in their recent Speech From the Throne.

In the midst of the uncertainty, we continue to try achieve a renewed collective agreement to protect the UCTE members at the port should a sale go through and will continue to pressure both the provincial and the federal government to take solid action to restore rail service and get the port operational for the 2018 shipping season.

### RESPECT VEGREVILLE

On July 19, I joined NDP Critic for Immigration, Refugees and Citizenship MP Jenny Kwan along with Linda Duncan, NDP MP for Edmonton Strathcona, Shannon Stubbs, Conservative MP for Lakeland, Jessica Littlewood, NDP MLA for Fort Saskatchewan-Vegreville, the CEIU NVP and Local Executive members in Vegreville.

The meeting was scheduled with Vegreville mayor Myron Hayduk and most of the town councillors to discuss the impact of the CPC closure. All parties had an opportunity to express their concerns in their first face-to-face exchange and the group committed to continuing to work together.

Jessica Littlewood spoke to the province's commitment to contribute to enhanced postsecondary opportunities in the Vegreville and surrounding areas—one of the main concerns cited by the department for the closure of the CPC. Myron Hayduk said the town has approved re-zoning to address access to housing which is another one of department's concerns about the viability of keeping the CPC in Vegreville.

In January 2017, Prime Minister Justin Trudeau held a Town Hall at the University of Saskatchewan. In response to a question about the Vegreville Case Processing Centre closure, he said: "Compensation and packages will be made available to those employees who do not wish to relocate."

However, the Department of Immigration, Refugees and Citizenship has since informed public service workers who do not wish to relocate that there will be no compensation and no packages. In fact, those who do not accept the department's final offer to relocate will be laid off in August 2018.

That's not right. And that's not what the Prime Minister said would happen.

We are fighting this broken promise through the policy grievance process, while also continuing the fight to keep the Vegreville CPC open. But at the very least it's not too late for the department to change course and keep the promise made by Prime Minister Trudeau.

On Nov. 27th, Sister Robyn Benson, National President and I toured the Vegreville Immigration Case Processing Centre and met with the Director to express our opposition to the closure and relocation Edmonton. Thank you to CEIU Local 30851 for the invitation to your Holiday dinner and membership meeting.

On Dec. 6<sup>th</sup>, Sister Robyn Benson, Sister Michelle Henderson, CEIU RVP Alberta and myself were to meet with Minister Hussen regarding the closure. Just hours prior to the meeting, the Minister cancelled but we were able to meet with the Minister's Chief of Staff and department officials. The rationale for the closure is still a moving target with different reasons and we are awaiting further information promised by the department officials. We are also awaiting confirmation of a meeting with Sister Benson and the Minister.

## PROVINCIAL POLITICS

On July 4, the Partnership to Defend Public Services, a group of public sector unions, filed for an injunction against the so-called Public Services Sustainability Act, recently passed by the Manitoba government. PSAC is one of the unions involved in the Partnership. This law fundamentally undermines collective bargaining rights. The Partnership filed a statement of claim in the Court of Queen's Bench challenging the constitutionality of the Public Services Sustainability Act. The action includes a request for an injunction that would prevent the government from proclaiming the Act.

On August 10, 2017 Saskatchewan Premier Brad Wall announced that he would be stepping down/retiring. Scott Moe was selected as the new leader of the Saskatchewan Party on January 27, 2018.

The Official Opposition of Saskatchewan, NDP is also in a leadership race. Two candidates have declared and the date of the leadership convention has recently been moved forward to March 3, 2018.

On September 16, Manitoba NDP members selected Wab Kinew as their new leader and the Leader of the Official Opposition.

In Manitoba, I spoke at legislative hearings on Bill 23, the Fisheries Amendment Act. Our members at the Freshwater Fish Marketing Corp. Winnipeg processing facility are the engineers that maintain the plant's equipment.

We are concerned with the government's decision to introduce Bill 23, especially the decision to withdraw from its participation agreement under the Freshwater Fish Marketing Act. While we acknowledge that fishers will still have the option of selling their fish via the FFMC, PSAC believes that a fundamental link in the fishing economy will be severely damaged – hurting fishers, their communities, and undermining the workers at the processing centre in Winnipeg.

PSAC believes that FFMC should remain a monopoly single-desk for the economic security and stability of all Manitoba fishers.

FFMC was created in 1969 and is located right here in Winnipeg. It was designed to give our small fishing communities strength and stability in terms of price and quality. Time and again, we have seen the ideological approach to "market freedom" has the same effects: small operators are cut out and wages are depressed.

In many ways, this feels like a re-play of the disastrous decision to dismantle the Canadian Wheat Board. While we submitted a written brief to the Legislative Committee, I took the opportunity to explain the similarities between the current situation in Churchill and the Federal Conservatives decision to dismantle the Canadian Wheat Board. I also supported northern indigenous fishers who presented to committee by calling on the provincial government to further develop a strategy and draft regulations before proclaiming Bill 23.

On behalf of PSAC members in the Alberta, I wrote to Premier Notley to congratulate her and her government on passing legislation to support Gay-Straight Alliances in Alberta schools. The letter which was jointly signed with Brother Chris Little-Gagné, PRC LGBT Representative was well received by both the Premier's office and the Minister of Education's office.

The positive impact of Gay-Straight Alliances and other similar student organizations is clear. Bill 24 ensures that students can have access to peer support when they need it the most, and that every single school in Alberta that receives public dollars must have a policy that clearly allows students to form a gay-straight alliance. Because these policies will be made public by school authorities, there will be transparency and accountability to the students and communities they serve. It is vital that students know that their right to access the support they need is not subject to the whims of any one institution or individual.

### TAKING ACTION AGAINST GENDER BASED VIOLENCE

November 25th to 27th, 2017 the Calgary Regional Women's Committee hosted the "A Women's Place is in Her Union" Retreat. This 3-day event included an evening of fellowship and conversation on November 25th, the course "A Women's Place is in Her Union" and a workshop on Domestic Violence in the Workplace and Murdered and Missing Indigenous Women and Children, followed by a lunch. I was able to attend, as well as Sister Benson and guest speakers Constable Maria Wren of the Calgary Police Service's Domestic Conflict Response Team and Josie Nepinak of Awo Taan Healing Lodge Society.

The course kicked off the 16 Days of Activism against Gender Based Violence.

For the National Day of Remembrance and Action on Violence Against Women, Regional Women's Committees from throughout the Prairies attended local events. In Saskatoon, the Regional Women's Committee met on December 6<sup>th</sup> and had a presentation on the Montreal massacre. In Winnipeg, members attended the sunrise vigil at the Manitoba Legislature and the Manitoba Federation of Labour's commemorative brunch, where NDP MLA Nahanni Fontaine delivered a bracing speech about the experience of the families affected by Missing and Murdered Indigenous Women and Girls. Edmonton members attended the AFL Commemorative Brunch December 3<sup>rd</sup>.

### WINNIPEG AIRPORT STRIKE

On July 4, 2017 at 3:00 a.m., UCTE 50600 members hit the picket line. While monetary compensation was an issue, the main priority for the members at the Winnipeg Airport Authority was management's excessive use of contractors. Throughout the strike that ended on Oct. 4, 2017, we had strong support from the Manitoba Federation of Labour and affiliates, including the Manitoba Teachers' Society and MAHCP which was very active on our behalf and in support of picketers on the line.

Even with an injunction limiting picketing locations, UCTE members were able to maintain effective and visible picket lines. Several rallies were well attended by other PSAC members and other unions.

Many thanks to PSAC locals and other unions who collected donations and organized picketers. As we have all faced the threat of contracting out and/or privatizing, it is important that we support all efforts to stop the trend. Congratulations to the members of UCTE 50600 for standing solid against their employer's attempt to pit members against each other and weaken their collective agreement.

## PHOENIX PAY SYSTEM

PSAC and other unions representing federal public service workers are working together to ensure that the government pays damages to its employees for the ongoing Phoenix fiasco. PSAC has also been continuing to mobilize to keep the pressure on the

government to fix the troubled pay system. PSAC members across the country are holding demonstrations in front of their MP's offices.

PSAC's priority remains getting our members paid correctly and on time. We welcome any system that would pay our members. It is unacceptable that, after nearly two years, the federal government still can't pay its employees properly.

We know that our members are struggling with the consequences of inaccurate pay and PSAC will continue to push the government for additional help and support for our members. The government needs to step up its hiring process and expand the compensation capacity both in the pay centres and in departments.

## **REGIONAL BARGAINING**

Employees at the Freshwater Fish Marketing Corporation in Winnipeg ratified a new collective agreement in November.

The newly formed Academic Capacity unit at the University of Saskatchewan has ratified its first collective agreement in October. Negotiations for Post Doctorate workers continue at the University of Saskatchewan.

A critical round of bargaining is underway for DCL Local 40004 at Casino Regina. With the Saskatchewan Party mandated wage cut of 3.5% still not withdrawn, our members are focused on supporting the bargaining team and strategizing on working with other unions.

Negotiations are underway for the UVAE members at Deer Lodge Centre in Winnipeg. Similar to Sask., UVAE members are subject to Bill 28 which mandates 2 years of 0%, 1 year of 0.75% and 1 year of 1%. PSAC Prairies is participating in a charter challenge with other unions looking to have Bill 28 declared unconstitutional.

Negotiations for UCTE members at the Port of Churchill are progressing slowly but the goal is to have a tentative agreement in place should any sale of the Port be finalized.

Bargaining demands have been prepared and negotiations will soon commence for UCTE Local 50602 SRG members at the Winnipeg Airport Authority.

Negotiations continue at CAHRD (Canadian Aboriginal Human Resource Development) DCL 55602.

Notice to bargain has been issued at the Calgary Airport Authority in behalf of UCTE Local 30301.

Negotiations are currently underway for the firefighters at the Edmonton Airport Authority. A priority of the bargaining team is to close the gap with other Edmontonarea firefighters.

A tentative agreement has been reached for the English Language Program at the University of Winnipeg. First contract negotiations for the Research Associates/Assistants Unit, and the Academic Capacity Unit is in negotiations for its second contract.

A tentative agreement has been reached at Brandon University. In this round of negotiations, we were faced with the Public Service Sustainability Act (Bill 28). This new legislation introduced by the Manitoba Progressive Conservative government imposes a

2-year wage freeze on all public sector workers – including students who work at BU – and wage restrictions for another 2 years. This legislation violates our constitutional right to free collective bargaining, and we have joined forces with other unions to file a court case against the Pallister government.

Following a difficult round of negotiations, UNE members at the Canadian Museum of Human Rights ratified a collective agreement on December 20th. This is the second agreement for this bargaining unit and the first agreement negotiated since the Museum officially opened. A priority for the bargaining team going into this round of negotiation was for issues related to front line staff and managements use and abuse of precarious workers. The team was successful in gaining protections for these members.

On a national note, Treasury Board members for the PA, SV, TC and EB tables will be attending the national bargaining conference in Ottawa March 26-29<sup>th</sup>. Bargaining team members will be elected for the upcoming round of negotiations. CFIA members are currently voting on a tentative agreement via webinar presentations and face-to-face meetings.

# REPORT OF THE REGIONAL EXECUTIVE VICE-PRESIDENT, PRAIRIES TO THE NATIONAL BOARD OF DIRECTORS

October 17-20, 2017

This report covers the period from the last NBOD meeting in June.

#### PRAIRIE REGION COUNCIL

On July 7–8 in Saskatoon, we held our first Prairie Region Council meeting since the Prairie Region Triennial Convention. It was a successful event that brought activists together from across the prairies. With over half of PRC members newly elected, the first day focused on orientation and a discussion of roles and responsibilities.

Dates were set for conference calls and for the face-to-face meeting in February 2018 which will also include a one day session with Prairies National Officers. The focus of the February

meeting will be to start mobilizing to federal and provincial elections and strategies to increase engagement of members.

### **MEETING WITH PRIME MINISTER TRUDEAU**

When Winnipeg members learned that Prime Minister Justin Trudeau would be in Winnipeg on July 29, an impromptu early morning info picket was set up outside the hotel where the PM was meeting with the Manitoba Premier, Brian Pallister. Following discussion with RCMP and PM security staff, I was invited into the hotel for a 5 minute face-to-face with PMJT. Brother Dave Clark, newly-elected National UCTE President also joined attended. Issues discussed included the UCTE 50600 Winnipeg Airport strike, the Vegreville CPC closure and the struggles and pain caused by the Phoenix pay system, and the urgency of a swift resolution to the closure of the Port of Churchill and OmniTrax's refusal to repair the rail line to the community of Churchill. No commitments were made and the meeting. FYI, we took 10 minutes!

## **POLITICAL ACTION & CAMPAIGNS**

#### WINNIPEG AIRPORT STRIKE

Approximately 150 hard-working duty managers, administrative workers, tradespersons, IT specialists, airfield maintenance workers and laborers at the Winnipeg Airport have been on strike at the Winnipeg Airport since July 24. They have been without a contract since June of 2016.

No one wants to be on strike. Our members know how much the Airport means to families. It means a lot to their families, too. That's why this is so important to us. Airport workers deserve to be treated with respect. Instead, the Winnipeg Airport has praised our workers for the conduct on the line, while going to court and arguing that PSAC pickets constitute a danger. That's not right. And it doesn't show respect for workers.

The Winnipeg Airport likes to pride itself on being one of Manitoba's Best Employers. But they are pushing for contracting out provisions that would hurt their employees and drive down wages. We will fight this heavy-handed approach with everything we have, and call on all workers – both unionized and non-unionized – to stand together and send a firm message to Barry Rempel and the Winnipeg Airport: "Contracting Out Won't Fly. Come Back to the Table With a Fair Deal."

We have been so honoured by the support we have been shown by our sisters and brothers in the union movement. On July 28 there was a large rally in support of PSAC/UCTE Local 50600 with about 300 people in attendance. We have had strong support from the Manitoba Federation of Labour and affiliates, including the Manitoba Teachers' Society which has been very active on our behalf and in support of picketers on the line. Our members attended the crucial "Care Not Cuts" rally on September 13 to show their solidarity with health care workers

in Manitoba. Members also attended the Winnipeg Labour Council (WLC) Labour Day March and BBQ. Attendees cheered their support loudly and thanks to the WLC, they left with almost 20 cases of potato chips that were left over from the BBQ (due to massive rain right before the BBQ was to start). As well, I was given the opportunity to address the 1,100 delegates at the Manitoba NDP Leadership Convention September 16 with the members on strike to address our concerns.

Many thanks to the components who collected donations at your conventions. As we have all faced the threat of contracting out and/or privatizing, it is important that we support all efforts to stop the trend.

Thank you again for your solidarity. I know it's been difficult to navigate away from the airport and we remain hopeful that we will be able to reach a tentative agreement.

#### RESPECT VEGREVILLE

October 19 will be the second anniversary of the election of the current Liberal government. It is also the date that public service workers at the Vegreville Case Processing Centre (CPC) will have to choose to leave their home, quit their jobs, or face a three hour commute because of the decision to close this centre.

On July 19, I joined NDP Critic for Immigration, Refugees and Citizenship MP Jenny Kwan along with Linda Duncan, NDP MP for Edmonton Strathcona, Shannon Stubbs, Conservative MP for Lakeland, Jessica Littlewood, NDP MLA for Fort Saskatchewan-Vegreville, the CEIU NVP and Local Executive members in Vegreville.

The meeting was scheduled with Vegreville mayor Myron Hayduk and most of the town councillors to discuss the impact of the CPC closure. All parties had an opportunity to express their concerns in their first face-to-face exchange and the group committed to continuing to work together.

Jessica Littlewood spoke to the province's commitment to contribute to enhanced post-secondary opportunities in the Vegreville and surrounding areas—one of the main concerns cited by the department for the closure of the CPC. Myron Hayduk said the town has approved re-zoning to address access to housing which is another one of department's concerns about the viability of keeping the CPC in Vegreville.

MPs Jenny Kwan and Shannon Stubbs agreed to work together to draw attention to the issue when the House of Commons returns for fall session. This timeline also falls in line with the deadline that the employer has given CPC workers to decide if they will take a position in Edmonton or forfeit their jobs.

Jenny Kwan called attention to the work that the various stakeholders have done to date to try to save the Vegreville CPC in a July 17 letter. She urged the Minister to intervene and halt the plans to close the CPC.

Invitations to visit Vegreville have been disregarded by Ahmed Hussen, Minister of Immigration, Refugees and Citizenship, and Prime Minister Justin Trudeau.

An updated online letter has been posted to the <a href="www.respectvegreville.ca">www.respectvegreville.ca</a> website along with an updated flyer. A meme and facebook/twitter post has been posted on social media to garner attention to the deadline and the Liberal government anniversary.

### **SUPPORT OUR PORT**

It is clear that Omnitrax is not willing to live up to its responsibilities, having renounced its obligation under the 2008 contract that it signed with the federal and provincial governments to keep the rail line operational and conduct needed repairs. Now businesses are suffering, food prices are soaring, and there is no end in sight.

PSAC has consistently called on the federal government to bring the Port of Churchill and the rail line back as a national asset so that it can return to full operation in the short term, and remain so for generations to come The recalcitrant position that Omnitrax has taken over the past year only highlights further the need for this kind of action.

The people of Churchill deserve a path forward that protects their future and treats them with respect. It is time to put an end to this desperate situation and provide real solutions, now.

In co-ordination with UCTE, I had an Op-Ed published in the Winnipeg Free Press entitled "Where's Merv?", calling on former Conservative MP and now Omnitrax Canada President Merv Tweed to sit down with workers and affected communities to come up with a real plan to fix the rail line and support our port.

Although time is running short, the federal government has recently made public statements suggesting that they are willing to step up and ensure that repairs are made to the rail line.

A joint letter from Brother Dave Clark and myself was sent to Minister Jim Carr requesting a meeting with Wayne Wouters who has been appointed by government to negotiate the transfer of the rail line and the Port from OmniTrax to the joint consortium of First Nations and northern communities. No response received as of the time of this report.

### **PROVINCIAL POLITICS**

On July 4, the Partnership to Defend Public Services, a group of public sector unions, filed for an injunction against the so-called Public Services Sustainability Act, recently passed by the Manitoba government. PSAC is one of the unions involved in the Partnership. This law fundamentally undermines collective bargaining rights. The Partnership filed a statement of

claim in the Court of Queen's Bench challenging the constitutionality of the Public Services Sustainability Act. The action includes a request for an injunction that would prevent the government from proclaiming the Act.

On August 10, Saskatchewan Premier Brad Wall announced that he would be stepping down/retiring. This launched a leadership campaign in the governing Saskatchewan Party. PSAC members will push each and every leadership candidate to commit to stopping the attacks on public services and privatization efforts that have characterized this government.

The Official Opposition of Saskatchewan, NDP is also in a leadership race. Two candidates have declared and the date of the leadership convention has recently been moved forward to March 3, 2018.

Union of Veterans Affairs Employees conducted an information picket in front of Deer Lodge Centre on August 10. Our members proudly provide care and service to the Canadian veterans that are residents of Deer Lodge Centre. They are extremely concerned with the Winnipeg Regional Health Authority's decision to eliminate food service onsite at Deer Lodge and to instead bring in meals from the Regional Distribution Facility. Members, residents and other unions took to the street to protest the WRHA's austerity cuts.

On September 16, Manitoba NDP members selected Wab Kinew as their new leader and the Leader of the Official Opposition.

#### **COMMITTEES IN ACTION**

**National Public Service Week** was held from June 11–17, 2017 to mark the importance of federal public service employees and recognize their service to Canadian society. During the week, members throughout the Prairie Region organized alternative NPSW events to call the employer on their hypocrisy and tell the federal government to put its money where its mouth is and demonstrate real respect and Fix Phoenix, rather than empty gestures.

In Winnipeg, several different events were held at various worksites throughout the week. UHEW Local 50012 held a lunchtime event at 391 York with almost 250 workers in attendance. They handed out stickers and flyers, and had members sign postcards.

Approximately 60 members from USGE Local 50015 visited the PSAC tent outside the RCMP D-Division on Portage Avenue. The event created awareness about the Phoenix Pay System problems, but also gave members the opportunity to discuss the national PSAC/USGE organizing campaign for Civilian Members of the RCMP.

On Wednesday of NPSW, dozens of Winnipeg members showed up for a march and rally, despite pouring rain. The march began at the Manitoba Legislative Building and ended at Upper Fort Garry Heritage Park. The skies had cleared and the sun was out for the rally and BBQ at the park, and PSAC National President Robyn Benson was in attendance to speak about the

postcard campaign. There was also a separate event held by UHEW Local 50012 outside the National Microbiology Lab.

UTE Local 40023 and the Saskatoon Area Council hosted a lunch event. Approximately 150 members came out to the rally in support of the Fix Phoenix campaign. Members were treated to a sandwich, drink and a cookie. They also received stickers and the postcard, which they committed to sending on.

During the employer-organized BBQ at CFB Suffield in Alberta, Local Executive members from UNDE 30910 and UNDE 30907 handed out letters addressed to Glen Motz, MP for Medicine Hat-Cardston-Warner, and Prime Minister Justin Trudeau, condemning the Phoenix Pay System and the delay in signing the ratified collective agreements with four Treasury Board bargaining units. Many of the members were personally affected by Phoenix and almost 150 people participated in the letter signing action.

The Calgary Area Council held a Boycott National Public Service Week event in the Atrium of the Harry Hays Building. Area Council members distributed 450 icecream bars to members to help them cool off after being Burnt by Phoenix. All of the ice cream bars were handed out in under an hour, along with hundreds of stickers, flyers and post cards to mail to Scott Brisson.

**Pride** activities were a major focus for members during the summer months.

Lethbridge Pride is a weeklong event that runs from June 19 – 25th, ending with the Pride Parade. This year the Lethbridge and District Area Council financially contributed to two crosswalks including the pride flag (rainbow colored) and the world's first transgendered flag (pink, white and blue) that are showcased in downtown Lethbridge.

PSAC members showed their pride during the Winnipeg Pride Parade on Sunday, June 4, 2017. More than 40 people marched with PSAC in the parade, the largest turnout we have seen for this event. Members of the Winnipeg Human Rights Committee planned and created a float for the parade with decorations, music and an excited delegation of volunteers who handed out Pride-themed flags, stickers, tattoos and dog tags to the crowd. Everyone was very excited to be a part of this exciting event and will no doubt return next year as our presence at Pride continues to grow. Members also attended the second annual Steinbach Pride parade.

Members of the Calgary Regional Women's Committee participated in "Keeping the Circle Strong" a Family Festival and Powwow held June 24, 2017 at the Calgary Stampede Grounds to celebrate **National Aboriginal Week**. PSAC had a tent on the site, with our famous "Wheel of Questions" and lots of swag to give away to our visitors, as well as suckers and temporary tattoos to give to the kids. We had information about Jordan's Principle at the tent and had some questions related to that on our wonderful "Wheel of Questions." Our committee member Vicky Norris was an organizer of the event and she decorated the wheel so that it had a really eye catching aboriginal theme. The booth had many visitors and we discussed a wide variety of matters such as childcare, Jordan's Principle and Phoenix with members of the public.

June 21st was National Aboriginal Day and the Lethbridge and District Area Council helped to support events that were taking place in Lethbridge Galt Gardens. Sr. Krysty Munns was lucky enough to be able to partake in a teaching tool to share the historic and contemporary relationship between Indigenous and non-Indigenous peoples in Canada called the Blanket Exercise. The LDAC also supported a Pow Wow at the Lethbridge Research and Development Centre which was organized by First Nations Co-op Students who are working at the center. There were young drummers from the local elementary school who were learning to drum as part of their culture as well as young women who were learning the jingle dance and the fancy dance. This event was well attended by students, members of the community, management and members from AGR 30048.

The Regina Human Rights Committee organized a candlelight vigil at the Saskatchewan Legislative Building on Monday, June 12 during the Queen City Pride Festival, held June 9 to 18 in Regina. About 50 people attended the vigil, which honoured the memory of the victims of the 2016 Orlando nightclub shooting. PSAC members collected 49 pairs of shows to display during the vigil, representing the 49 innocent people that lost their lives. Trent Wotherspoon, the then interim leader of the Saskatchewan NDP, spoke at the event. At the end, people were encouraged to take a seedling tree home with them to represent that life continues. The 49+ pairs of shoes displayed during the vigil were donated to shelters across Regina.

The Edmonton Regional Women's Committee has three initiatives underway: one is a garden, and vegetables are donated to senior women living at the poverty level; a grocery card campaign to raise funds to purchase grocery cards for seniors; and the RWC conducted a oneday seminar on Universal Childcare on September 16. 16 members from 10 different components were in attendance and were presented with the opportunity to see presentations from three very strong women advocates around the topic of a Universal Childcare System. NDP MLA Marie Renaud spoke about the NDP initiatives currently taking place, Morna Ballantyne presented the PSAC campaign initiatives and Siobhan Vipond from the Alberta Federation of Labour gave a presentation sharing some great tips for lobbying government. Once all three speakers completed their presentation a panel was set up for questions from the participants. After lunch, participants of the seminar took to the streets in a March for Universal Childcare. Opening remarks for the March were given by Patricia Jessome, Chair of the Regional Women's Committee and for 30 minutes they held their flags, blew their whistles and called on the government of today to make a Universal Childcare Program a reality for ALL Canadians. In the afternoon participants had table discussions about the reality of childcare and have built an action plan for the Northern Alberta Regional Women's Committee to continue in the fight for quality, affordable and accessible childcare.

The Winnipeg RWC conducted a School Supply Drive for the families of Winnipeg Airport workers on strike as they transitioned back to school. Many thanks to all involved in this important initiative.

UNDE 501705 held a payday demonstration at the base in Winnipeg on August 9 to protest Phoenix issues. As a result of this, the Winnipeg Area Council has held three information pickets at MP Jim Carr's office in a row. Challenge received, challenge accepted!

PSAC members were well represented at **Labour Day** events throughout the Prairies.

The Lethbridge Area Council participated at the Labour Day Family Picnic by providing a generator and bouncy castles and helium for PSAC balloons. Members from the area council supervised children at the bouncy castle throughout the day. A tent was set up where members spoke about the Public Service, Phoenix issues and handed out PSAC swag. The Area Council also supported members in Medicine Hat by contributing some funds to cover the cost of bouncy castles at their Labour Day Picnic. Sr. Danielle Poissant (Union of National Defence Employees Local 30907) organized this event in conjunction with the Medicine Hat Labour Council.

The Saskatoon Area Council members were busy handing out helium balloons, stickers, frisbees and suckers at their Labour Day activities, where there was a record attendance and perfect weather.

The Calgary Area Council was instrumental in planning participation and support for the annual Labour Day BBQ working with the Calgary and District Labour Council.

In Regina, members set up the Prairies tent on the grounds of the Sask. Legislature and distributed rulers, pencils, crayons, erasers, frisbees, balloons and water bottles. They had an opportunity to speak with MP Erin Weir and expressed frustration that many PSAC members are still plagued with Phoenix related pay issues.

In Winnipeg, despite rain and cold weather, a shorter version march went forward and a BBQ followed. I addressed the crowd of about 300 people with Winnipeg Airport workers. PSAC had a booth and handed out materials related to Phoenix and other PSAC issues. Brandon members joined festivities in their community for the first time in many years. The Area Council used our prize wheel to entice community members to come over to hear about our issues.

On September 10, Winnipeg PSAC members and some family members took a road trip to the Shoal Lake reserve Water Museum. After a bit of a drive and a ferry crossing, members were guided on the reserve and through a museum documenting the lack of clean potable water. Members came back reflecting how these conditions could exist in Canada. The reserve does not even have access to medical help on the island. Following a 4 hour tour and with much left unseen, members were treated to a lunch of wild rice soup and fry bread. Another tour is being planned for October pending availability of the guide.

#### **NEGOTIATIONS**

Notice to bargain has been issued for SRG Security Resource Group, Edmonton Airport GBU, and Freshwater Fish Marketing Corp.

No negotiations are scheduled for a first collective agreement at Bouygues Energies and Services Canada Limited pending legal decision on whether Winnipeg Airport Authority is the true employer. If successful, the bargaining unit will be folded into the current UCTE General Bargaining Unit collective agreement.

Input call has been issued for ATCO 15 Wing, Moose Jaw.

We have a tentative first collective agreement at the University of Saskatchewan with the newly formed Academic Capacity unit. Academic workers will be voting on the tentative agreement on Oct. 3<sup>rd</sup>. Negotiations for Post Doc workers continue at the Univ. of Sask.

Bargaining is underway for our DCL Local 40004 at Casino Regina. Threats of a mandated government wage cut of 3.5% and the provincial government publicly declaring their intent to privatize crown corporations (Bill 40) will make for an intense round of negotiations.

Negotiations are starting soon for the UVAE members at Deer Lodge Centre in Winnipeg.

Negotiations for UCTE members at the Port of Churchill are stalled and we await information on whether the federal government is able to negotiate the sale of the Port and the rail line.

Negotiations are underway for the English Language Program at the University of Winnipeg. First contract negotiations are underway for the Academic Capacity and the Research Assistants at the University of Winnipeg. Negotiations also continue at Brandon University.

Negotiations continue the week of Sept. 25th at the Canadian Museum of Human Rights. A priority issue for the local is the high incidence of precarious work.

Negotiations are underway for All Nations Healing Hospital in Quapelle, SK.

Negotiations continue at Centre for Aboriginal Human Resource Development (CAHRD).

The week after my first PRC meeting held in Saskatoon last July 2017, I continue to support my fellow health care workers affected by Manitoba Premiere Brian Pallister's cuts. The target was comprising a massive network of workers and complex social infrastructure which forms the bedrock of the modern welfare state: lined up next at the budgetary guillotine is health care. The government's restructuring has already resulted in job cuts, which will negatively impact patient care including our members at the Deer Lodge Centre UVAE Local 50021, which they close the cafeteria, restructuring Food Services and bumping process for all the workers.

Our brothers and sisters at Winnipeg airport UCTE 50600 hit the picket lines after collective bargaining negotiations with the airports authority fell apart. The strike which involves 150 employees. Sister Marianne Hladun, PSAC Prairies REVP sent a

instruction for members on respecting the picket line at Winnipeg airport (and Toronto Pearson airport). All travel, union or personal, should be re-directed away from Winnipeg or Toronto Pearson. The Winnipeg Airports Authority and PSAC have reached a 6-year agreement that will bring the roughly 150 airport employees who've been on strike since July 24 back to work and ended by October 2017.

Winnipeg, Manitoba hosted the Canada Summer Games Last July 28 to August 13, 2017 which Prime Minister Justin Trudeau and Manitoba Premiere Brian Pallister meet at the Fairmont Hotel early Saturday morning of July 29, 2017. With the members of PSAC and Sister Marianne Hladun, Prairies REVP had a chance to show and even talked to the Prime Minister about Omnitrax, Vegreville Closure, Winnipeg Airport Authority Strike and the burning effect of Phoenix pay system.

## Shannon Blum Persons with Disabilities Rep Prairie Region Council February 2018

This position has been somewhat of an eye opener! I will admit, that part of me thought that moving in this role would be similar to being an Area Council Representative, a different demographic but similar requirements. It has not been and fulfilling all the plans I had made, while maintaining all my other commitments has indeed proven to be a challenge. However I have had the privilege of seeing some of the work that goes on behind the scenes to prepare for PSAC events, the chance to help members at other sites, and a view of the larger issues that are ongoing at other sites.

Here is a brief history of what I've been involved with during my term in 2017.

Return to Work and Accommodation. As anyone with a disability knows this is an ongoing problem for all Government Departments. I was acutely aware that it was often challenging in my own work location, but it's been interesting learning the intricacies of working in other departments as well. To date I've helped with representing approximately 20 individuals at 4 different locations in person, as well as advising countless others. This area will continue to be a focus for me.

<u>April 2017</u> – I attended the PRC pre-convention meetings and also the PSAC Prairies convention.

<u>July</u> – Participated in a PRC teleconference meeting and attended the USGE national Convention, where I was also elected Alternative Regional Vice President – CSC Saskatchewan.

<u>Sept</u> – I attended a PRC teleconference where some hard decisions were made, and where I was reminded once again that disabilities are often not considered at all, or very slightly unless the individual is articulate in expressing their needs and/or has an advocate. To my chagrin sometimes this is still not enough. We have a ways to go my friends, even within PSAC.

I also attended training and a National Executive meeting for my component.

Oct - I was able to join the Edmonton Human Rights Committee meeting via teleconference. We had a fair bit of difficulty technology wise, but with good humour on all sides was able to overcome. At this meeting we discussed the hardships involved with some seemingly arbitrary rules, and also made plans for a dream catcher event, which was ultimately successful thanks to the dedication of just a few people. This committee is small but mighty and deserves recognition for an amazing job!

<u>Nov</u> – November was a crazy month! I can honestly say some days I woke up and forgot where I was! I attended Local Officer Training, the USJE Bargaining Conference, worked with staff from the National and Regional PSAC Offices to review sites for the 2021 PSAC Triannual Convention, visited OOHL in Maple Creek and

attended Leadership Training.

I'd like to just take a minute to recognize just how much work goes into reviewing a site for a PSAC event, because I know I for one was completely clueless. The checklist just for disability accommodation is 4 pages long! Sites are reviewed by no less then 3 individuals who all report back on their findings and work together to (hopefully) not miss any important detail. It was fascinating for me to consider all the different challenges that people have, from carpets that wheelchairs can move over, to scent free floors in hotels, to sight assisted elevators and that only touches on a tiny margin of what is considered. It truly is essential that people completely and honestly fill out the needs section of their registration forms. If nothing else I walked away from this experience with the understanding that there is simply no other way to ensure that the needs of all individuals can be met. I encourage you therefore, even if you have an accommodation that you "might" not need that day, say for example some days you need extra time to move between locations, or some days you can walk and others you can't. Take the time to have a conversation with the PSAC staff in charge of the event, and please fill out the needs section. You are not judged on your needs! I saw extremely caring individuals doing the best that they can based on past data, but as we all know, each disability is unique with it's own challenges and needs. In this way your needs can be considered and addressed.

<u>Dec</u> – I attended my first National Human Rights committee meeting. I was both pleased and disappointed with the experience. It's difficult to get nearly enough time for each need of the committee in the time period allotted, however I do believe that we need to be more understanding of everyone's needs when working in a group that large. Our smaller group sessions I felt were very productive and resulted in plans that can be implemented. I do feel that the decision to tag it on the Leadership Training, while fiscally responsible, was not successful in application. Many members were already exhausted from long days, some like myself and others were dealing with their own physical and mental challenges of being away from home and routine for an extended period and lastly it resulted in a day being shaved off the time we had to meet. This left many reports not presented, and most limited to only 5 minutes. Not nearly long enough to be complete and no time for Q &A.

<u>Jan 2018</u> – Unfortunately due to my own disability I was unable to participate in work or union. It's been challenging knowing that there is needs going unmet and people unsupported, but that if I do not look after myself I will not be able to help anyone else either.

## In the end what I've taken away so far is:

- We may have come a long way, but complacency breeds contempt and we have a long way to go yet.
- Accommodations, and return to work programs are almost ALWAYS challenging and they do not need to be.

- We need to find a way to ensure that the information of people who self identify can be shared with the people representing them. Each new PRC representative must make their own contact list over again, potentially every 3 years the process starts again, and I do not believe we should depend on sharing between past incumbents because PRC members are elected and not everyone handles losing an election well.
- If I do not look after myself, I cannot help ANYONE.

## Deb Kosteniuk RWC Rep Prairie Region Council February 2018

RWC's were active across our region this fall and winter, focusing on Phoenix issues, childcare, domestic violence in the workplace, murdered and missing indigenous women and children, as well as community projects.

## Winnipeg:

The Winnipeg RWC is very active. They have participated in Phoenix rallies throughout the summer, fall and winter. They participated in the Labour Day Barbecue.

September 10, 2017, they, along with other PSAC activists such as Brothers Frank Janz and Gus Mardli visited the Shoal Lake 40 First Nations Reserve. Shoal Lake 40 has been on a boil-water advisory since 1997. There were no Sisters in Spirit Vigil planned for Winnipeg, but the RWC participated in the Take Back the Night March in October. They have planned various charitable drives throughout 2017 into 2018: school supplies, feminine hygiene products, and an underwear drive for Centre Flavie Laurent for example. They were involved in coordinating donations of beds from the Summer Games to two centres that they support. They planned events for the 16 days of Activism against Gender-based violence and the National Day of Remembrance and Action on Violence Against Women. They participated in the A Women's Place is in Her Union PSAC training course. They are involved in a Ju Jitsu course at the Wii Chiiwaakanak Learning Centre offered on Mondays from 7 to 9 p.m. Their AGM was held January 9, 2018. They participated in PSAC committee training January 17, 2018. They had a large presence at the Winnipeg Women's March held January 20, 2018 and the event received very good media coverage. Reports state 300 to 500 people marched and rallied in Winnipeg.

#### Northern Alberta:

The Northern Alberta RWC is also very active. For 2017 spring, summer and fall, they did a community garden project that saw the harvests from the garden going to Seniors in need through the SAGE (Seniors Association of Greater Edmonton) program. September 16, 2017 they held a Childcare Seminar and Rally. They had 15 participants for the seminar and they called locals prior to the event to promote it and gain attendees. Morna Ballantyne was one of the key speakers. For the Rally, they reached out to allies such as Public Interest Alberta, Edmonton District Labour Council, the CLC, and other unions. Kirsten Strachey of Calgary RWC was in Edmonton and participated in the Rally with the women of the NA RWC. They planned a campaign called Food for Women – with the idea money raised would be used to purchase grocery store gift cards that would be donated to women in need sometime before Christmas. They had raised \$1000 for that project by mid October and were personally calling locals for donations. They presented a Wreath for Remembrance Day. They joined affiliates for the National Day of Remembrance and Action on Violence Against Women at the AFL They are planning a 2018 childcare campaign "What's Your Story" with the idea that a FB page or website be developed to start personal conversations around childcare. They participated in the January 20, 2018 Women's March -Edmonton had around 1,000 participants for the March. The March was well covered by media.

## Calgary RWC

We participated on a "Burned by Phoenix" boycott NPSW event at the Harry Hays Building June 14. We participated in the Aboriginal Day Family event June 21, manning the PSAC booth and talking about MMIW, potable water issues, Jordan's Principle. We

did an email campaign asking all locals and components to wear orange shirts for September 30, 2017. We were a presence at the October 4 Sisters in Spirit Vigil, and made a financial contribution to Awo Taan Healing Lodge Society, the Vigil organizers, for the bagged lunches given to Vigil participants. We organized and held a Grand Opening event for the new Calgary Regional Office October 12; we were pleased to have Sister Robyn Benson in attendance for that. We organized A Women's Place is in Her Union Retreat Nov 24 to 26/17 together with Dolly Ablitt, our Regional Rep. It incorporated the PSAC course "A Women's Place is in Her Union" along with two workshops; one on domestic violence and the other on MMIW. We had 20 register for the event, with four dropping out due to illness. We started with Friday night registration and welcome event featuring a Raclette Supper, the course on Saturday and the workshops and lunch on Sunday. The course utilized three of our members who are AFI facilitators which was wonderful to see. The RWC "catered" the Friday night supper and Sunday workshop lunch ourselves. Starting November 25 and ending December 6, we did a Facebook campaign for the 16 Days of Activism on Gender Based Violence, utilizing our Calgary RWC page. We did not hold a December 6 event but let members know about events being held by our allies in Calgary. We did an email campaign to components and locals asking for participants for the Women's March and several members of our committee participated in the Women's March on Jan 20/18. 3500 marched in Calgary and there was very good media coverage.

## Lethbridge:

Lethbridge RWC put on a strong show for the 2017 Women's March and have remained involved with March On Canada, posting March On Canada items of interest on the PSAC Prairie Regional Women's Committees page throughout 2017 and into 2018. Like many other women across the Prairies, our Lethbridge RWC women are involved with, or part of Area Council. In Lethbridge the LDAC sponsors PSAC members in the Rotary Dragon Boat Festival in June. If there were not committee members rowing a dragon boat, they were there to support and cheer on their fellow PSAC members. Lethbridge RWC again supplied a bouncy castle for the Lethbridge Labour Day Picnic, which always is a huge crowd pleaser. Committee members made a financial contribution and attended the Lethbridge Sisters in Spirit Vigil on October 4. They participated in the University of Lethbridge Women's Centre Menstruation Drive, donating tampons and pads to the cause. They donated funds to the Persons Day Breakfast to cover the cost of a speaker at the event. They attended the YWCA Take Back the Night event. Lethbridge did not plan an event for December 6 but were planning to join a Vigil offered by an ally. They did a holiday giving project, with the women of the committee knitting caps and scarves for sisters in need. Lethbridge RWC Secretary-Treasurer Krysty Munns organized the Lethbridge Women's March On Solidarity Rally on January 20. After the Rally, a Living Library Event was held. It was a forum for attendees to learn more about programs, organizations and people that work with women in the community, plus a workshop about bystander intervention; a multimedia installation art project on Lived Experiences of Syrian Refugees and the Kairos Blanket Exercise. While the participation in the Rally was smaller than in 2017,

the Living Library was well attended and both the parts of the day received a lot of media coverage.

## Regina RWC

The Regina RWC led their third MMIW Mother's Day Walk in Regina and is planning for the fourth and final Mother's Day Walk and a possible feast for MMIW in 2018. They have had very good success with holding self defence courses for women, and they continued that success with their Women's Self Defence Course in September, 2017. From that they donated \$400 to Sophia House, made up of the trainer and participant RWC members attended two Sisters in Spirit Vigil activities: the Feast at the First Nations University of Canada and the MMIW Candle Light Vigil at the RCMP Depot. December 9, 2017 the RWC participated in an All Committee Meet and Greet for locals and affiliates like Regina District Labour Council and Saskatchewan Federation of Labour. They had a spoken word poet at the event and those attending were asked to bring a non perishable food item for donation to the Food Bank. Michelle Lang, Chair of Regina RWC, organizes and participates in rallies and events as much as possible. She has organized and help lead Phoenix Rallies, SFL campaigns and rallies against her Provincial government's actions, helped to organize the CBSA rally in Regina on December 19/17 and I know committee members participate in these rallies and events RWC members volunteered for the Unions of Regina Christmas Dinner on December 20, 2017, and the RWC made a financial donation to help cover costs of the meal. Regina RWC has held discussions about the resolutions passed at the EO Conference and the Prairie Region Triennial recognizing the need to lobby delegates at National to see these resolutions come into being. Michelle Lang, Chair of Regina RWC is one of the two women's delegates to National Triennial. I am looking forward to her lobbying efforts on behalf of Prairie RWC's.

## Saskatoon:

October 28 RWC held a Women's Social with the objective of recruiting membership for the RWC and possibly resurrecting an RWC in Prince Albert. This was an opportunity to invite participants in the "A Women's Place is in Her Union " course (held Oct 29) to attend the social and learn about the RWC. Leila White, Chair of the Saskatoon RWC did a presentation about the mandate of the RWC and their plans for 2018. After that she co-facilitated a wellness exercise, "Laughter Yoga." Leila also participated in part of the workshop the next day and answered more questions about the RWC. They held a December 6 event discussing the murder by misogyny that occurred in Montreal in 1989. The murdered women were remembered by reading of their names and there was a discussion on the importance of remembering them annually as well as how important it is to continue working to protect sisters from violence against women. They are supporting Moon Time Sisters and their drive to collect feminine hygiene products to women and girls in need – the RWC will promote by doing a poster and mail out to the locals. Saskatoon RWC intends to broadcast meetings live on Facebook to allow women who would like to participate who cannot come to the office for a meeting. The broadcast could also be reviewed by any committee member post meeting for feedback and input prior to the next meeting. They have also set dates for their 2018 meetings -

they will meet on the third Tuesday every other month, starting January 16, 2018. This RWC is rebuilding after a short period of inactivity; many of the events they planned for 2017 were not implemented. They are working on building the RWC into an active and dynamic entity in 2018.

# Stasi L'Hirondelle Northern Alberta Geographical Rep Prairie Region Council February 2018

Since my last report, the council has had two conference calls with plans to meet face to face February 9-11, 2018. During the conference call in September, the main topics discussed were strike actions taking place at the Winnipeg Airport, and Phoenix issues. I'm happy to say that the strike at the airport was resolved. Unfortunately, issues with Phoenix continue to happen and we will continue to rally and put pressure on the government until all issues have been rectified.

With all the continued issues with Phoenix, I've made numerous phone calls to my MP. I've explained my personal issues, as well as the issues many members across this region have been having. All Canadians deserve to be paid for the work they've done. I know there is still a lot of work to be done to fix all the errors with the Phoenix pay system, and I commit to standing behind PSAC and all members in this fight.

I continued my path to becoming a stronger leader by attending the PSAC National Leadership Training course held in Ottawa November 30 – December 3, 2017. There were some fabulous guest speakers and workshops to attend. My most memorable workshop was the Kairos Blanket Exercise. This is an interactive workshop that delves into the relationship between Indigenous and Non-Indigenous peoples. It was a very emotional workshop, and one I'd strongly advocate for more members to participate in.

During this time, I also attended a Labour Leaders meeting on behalf of the RVP, Marianne Hladun, where leaders of different labour organizations meet with Minister Amerjeet Sohi. I spoke to the Minister about the closure of the Vegreville CPC. To paraphrase, I stated that I know he's aware of the situation and has seen previous fact sheets and reports. But I wanted to reiterate that the closure of the processing centre would be devastating to Vegreville. There are approximately 240 employee's working at the centre in Vegreville, but are you aware that the per capita equivalent would be an employer removing 55,000 jobs from Edmonton? The arguments made by the

government to support the closure have been refuted, and as the Prime Minister campaigned on building strong rural communities, can we count on you to call for the reversal of the closure? Minister Sohi provided the same reasons for the closure that have been stated many times. I couldn't get a satisfactory answer, so I waited around after the meeting to speak to him a little longer. I asked him if he would provide support and go back to Minister Hussen and request that there is serious consultation with the union to look at viable alternative to the closure of the Vegreville office. He did agree that he would bring it up to the Minister. I also suggested that he visit the office himself to dispel the "myths" of the building being in disrepair. At the time of writing this report, it seems like the intent is still to close the CPC office.

I'm also pleased to report that I was nominated and selected to be a delegate to the upcoming PSAC National Convention in April by the Edmonton Area Council. This will be my first National PSAC triennial and I look forward to representing the members for my region.

## 2. TDOR letter (November 20 2017):

PSAC Prairies Statement: Trans Day of Remembrance

On November 20, communities across the Prairies, Canada and the world gather to remember those trans people who have passed away in the past year, including victims of transphobic violence. As we remember, we must rededicate ourselves to the struggle against discrimination and violence that too often targets transgender and gender-variant people.

We know that we have a lot to do. A <u>recent study of transgender youth in Manitoba</u> and Saskatchewan has found that nearly 50 per cent of school-age youth in Manitoba and Saskatchewan attempted suicide,

while 60 per cent had engaged in self-harming behaviour. These figures are both well above the already tragic national numbers. In Alberta, <u>results of a similar survey</u> show that almost 65 per cent of transgender youth have thought about suicide.

In Canada, we can finally celebrate the passing of Bill C-16, which will enshrine trans rights into Canadian law. This legislation adds gender identity and gender expression as prohibited grounds of discrimination under the Canadian Human Rights Act. It also adds gender identity and gender expression to the list of distinguishing characteristics of "identifiable groups" protected by the hate speech provisions in the Criminal Code. Ten of the 13 provincial and territorial jurisdictions already have similar legislation in place.

PSAC has been a strong supporter of the rights of our gay and lesbian, bisexual and trans members. We campaigned for C-16, and have bargained language in our collective agreements on issues such as discrimination on the basis of gender identity or gender expression, access to safe washrooms and change rooms, and the right to be referred to by one's chosen gender. This work continues.

All people deserve respect, equality and protection from discrimination and violence. We will do everything in our power to be better allies and put an end to transphobia and transphobic violence.

Premier Rachel Notley

RE: Congratulations on the passing of Bill 24

We are writing today to congratulate you and your government on the passing of *Bill 24: An Act to Support Gay-Straight Alliances*. With this legislation, some of the most vulnerable students in Alberta will now be protected in law.

The positive impact of Gay-Straight Alliances and other similar student organizations is clear. Bill 24 ensures that students can have access to peer support when they need it the most, and that every single school in Alberta that receives public dollars must have a policy that clearly allows students to form a gay-straight alliance. Because these policies will be made public by school authorities, there will transparency and accountability to the students and communities they serve. It is vital that students know that their right to access the support they need is not subject to the whims of any one institution or individual. No one can be outed for their participation in a GSA or QSA.

Unfortunately, this legislation has been subject to mis-informed and sometimes malicious opposition. While the majority of public discussion has been respectful and democratic, some public figures have chosen to use this legislation to further marginalize the LGBT community and promote fear.

By recognizing the benefits of these student organizations, including the very real potential to save lives, the Government of Alberta has placed itself on the right side of history.

### 4. Positive Space Letter:

January 9, 2018

Hello Activists.

I am writing to increase awareness of the *Positive Space Initiative*, which was based on the *Positive Space Campaign* of the Ontario Public Service. The initiative aims to positively enhance the work experiences of lesbian, gay, bisexual, transgender, Two –Spirit and questioning+ (LGBTQ2+) employees by encouraging the creation of a safer, more inclusive, and open-minded environment.

The creation of a Positive Space is committed to:

- providing a welcoming and inclusive atmosphere for people of all sexual orientations and gender identities:
- discussing sexual orientation and gender identities in a positive way; and
- referring questions on sexual orientation and gender identities to a contact person as appropriate. The Positive Space Initiative in the Ontario Public Service and many Government of Canada workplaces is there to train Positive Space Ambassadors as well as provide diversity training. Ambassadors then become visible in their workspace as a "positive space" for anyone dealing with sexual orientation or gender identity issues, or for anyone seeking more information on the subject.

While ambassadors may not be an expert on LGBTQ issues, they are committed to providing helpful resources and referrals, and to educate in contributing to a more diverse and inclusive public service. This Initiative is very important and should be taken on by all workplaces. Activists within the union should be on these initiatives to ensure that management is not just implementing to say they have one, but not creating an inclusive workplace.

## Gus Mardli South-East Manitoba Geographical Rep Prairie Region Council February 2018

Hello Sisters, Brothers and Friends

I hope you all had great Component Conventions last summer and fall. So let's all do what it takes to make our Region the best Region for the labour movement.

## Here is a list of activities I participated in:

\*On August 3<sup>rd</sup> I held a conference call for Local Presidents in the South East Manitoba to update locals on the PRC and to ask about their needs and their activities. I explained my role as a Geographical Rep and informed them of my plans on how to keep them informed and how I can be their voice on the PRC. Sister Sandra Ahenakew joined us as a guest and was introduced to presidents in attendance. Sandra spoke of her role as the Aboriginal Peoples' Rep on PRC as well and followed up with emailing them her contact information and other material and activities related to our indigenous sisters and brothers in the Region.

\*On August 9<sup>th</sup>, I participated with the Winnipeg Area Council at a special meeting to debate and vote on resolutions to be submitted to the 2018 PSAC National Triennial Convention.

At that same meeting, the Winnipeg Area Council decided to have a Phoenix Protest day on each and every payday to be held at either an MP office in Winnipeg or at a PSAC Local in Winnipeg.

- \*On August 23<sup>rd</sup>, The Winnipeg Area Council had their very first Phoenix Payday Protest in front of Minister Jim Carr Constituency office on Corydon Avenue in Winnipeg. Minister Carr was in Ottawa, as we were told by his Executive Assistant. - \*Labour Day Event this year was another success. We marched on Monday Sept. 4<sup>th</sup> despite the storm- from the Legislative building to the Vimy Ridge Park for the picnic. We received many compliments regarding our PSAC swag, and had many people coming back to our PSAC Tent for more.
- \*I protested **on September 6**th— with the Winnipeg Area Council the Phoenix Payday at the Minister Jim Carr Constituency office again. We couldn't meet with him that day either. His office offered us coffee though.
- \*On September 10th, I accompanied other PSAC activists for a trip to Iskatewizaagegan Reserve at Shoal Lake Ontario which was sponsored by the

Winnipeg Regional Women Committee. The trip was an eye opener as we witnessed how the reserve get contaminated water, no roads to the reserve but through water ferry, no septic system for the reserve. It was just like going back in time more than 5 decades.

- \*Participated in conference call with the PRC Health & Safety Committee and Brother Clint Wirth **on September 12**<sup>th</sup> as we went through the feedback we received from Health & Safety activists in the prairie region, to help us with drafting the Terms of Reference for the New Prairie Region Health & Safety Committee.
- \*I attended a PRC Conference Call **on September 14**<sup>th.</sup> I presented -on behalf of the PRC Health & Safety Committee- the work we accomplished concerning the Regional Health & Safety Committee's Terms of Reference.
- \*I protested **on September 20**<sup>th</sup>— with the Winnipeg Area Council the Phoenix Payday at the Minister Jim Carr Constituency office again. Sister Marianne Hladun joined us and got a chance to meet Carr's Consitituency office assistant in person. Again Jim Carr wasn't in town that day.
- \*Attended a Wiinnipeg Area Council meeting **on September 26**<sup>th</sup>, It was to plan for the Rememberance Day Wreath Laying and the Winnipeg Santa Claus Annual Parade.
- \*I protested the Phoenix debacle **on October 4**th— with AGR Local 50073 & the Winnipeg Area Council at 167 Lombard in Winnipeg. Answered some of by-passers questions about the Phoenix issues.
- \*On November 1st, The Phoenix Payday Protest took place at 111 Lombard Avenue in Winnipeg. I joined Locals 50262, 50757, 50758, 50770 and the Winnipeg Area Council. It was a great show so thanks to Sister Mackenzie Campbell (the PRC Young Workers Rep) and her local to provide everyone with Fairtrade coffee.
- \*On November 14<sup>th</sup> & 15<sup>th</sup>, I co-facilitated with Brother Clint Wirth a 2 day workshop on Violence in the Workplace at the Manitoba Federation of Labour (MFL) Health & Safety Conference.
- \*The Winnipeg Annual Santa Clause Parade took place **on November 18**<sup>th</sup>. I had the chance to assist Brother Frank Janz (very little) in decorating the PSAC Float entering in the parade. It wasn't as warm day as it was the last year. The Parade was still well attended and the float was very full of our PSAC activists who didn't walk and handed out candies. We still ran out of candy anyway.
- \*On November 28<sup>th</sup>, I was invited to attend UHEW Local 50012 Annual General Meeting. I updated the local on PRC work and activities and explained my role as their geographical rep. I also answered questions on the difference between the PRC council

vs their Component National Officers who resides in the prairies. I also ran their election for officers for them that evening.

\*The National PSAC Leadership training took place in Ottawa from November 30<sup>th</sup> – December 3<sup>rd</sup>. It was a great opportunity to attend workshops with PRC members as well as other PSAC activists.

\*On December 13<sup>th</sup>, The Phoenix Payday Protest took place at MP Doug Eyolfson Constituency office on Partage avenue in Winnipeg. I joined UNDE Local 50705 and the Winnipeg Area Council for this protest. MP Eyolfson wasn't in his office but I had the chance to speak to his Executive Assistant -Catherine Montgomery- as she was defending the Liberals and blaming only the Conservatives for the Phoenix implementation. I asked her to let Doug Eyolfson know that it is not acceptable to keep blaming the former government and that we need actions on moving forward, not just what had happened already.

\*On December 14<sup>th</sup>, I participated with the Winnipeg Area Council at a special meeting to hold a by-election for the Area Council Vice-President vacant position and the successful member is holding this position now is Sister Sheilagh Hanson.

\*The New Year's **Phoenix Payday Protest** continued **on January 24**th. I joined CEIU Locals 50772, 50767 and the Winnipeg Area Council at 280 Broadway in Winnipeg. This was the longest protest we had as we kept picketing on front of the building for more than an hour. Members kept coming and leaving as their lunch time staggered. Sister Basia Sokal (The Winnipeg Labour Council President) had joined us for the protest. It was a great success and a very good turnout.

I am looking forward to continue working with each and every member on the PRC as well as representing locals and members in South East Manitoba in a very productive cycle

## Krysty Munns Lethbridge Area Council Rep Prairie Region Council February 2018

Since my last report from the Lethbridge and District Area Council (LDAC), I attended the first Face-to-Face Meeting of the Prairie Region Council in Saskatoon, Saskatchewan in July.

In August, the LDAC participated in the Whoop-Up Days Parade in conjunction with the Lethbridge and District Labour Council. On August 29<sup>th</sup> the LDAC held a general meeting to discuss and debate potential resolutions for submission to PSAC National Convention to be held in Toronto. The meeting was well attended and we were able to put forth five resolutions from our committee. These were submitted on August 31<sup>st</sup>.

In September the LDAC contributed to the Lethbridge Labour Day Family Picnic with financially supporting a generator for bouncy castles and some helium for PSAC balloons. Members from the committee donated their time to supervise children at the bouncy castle throughout the day. A tent was set up where we spoke about the public service, Phoenix issues and handed out PSAC swag. The LDAC also supported members in Medicine Hat by contributing some funds to cover the cost of bouncy castles at their Labour Day Picnic. This was the first time PSAC was involved in the Medicine Hat Labour Day Picnic. Sr. Danielle Poissant (Union of National Defence Employees Local 30907) organized this event in conjunction with the Medicine Hat Labour Council.

During this term the LDAC held an Annual General Meeting on Oct 17<sup>th</sup>. A new executive was elected whereby I was re-elected president, Br. David Person (AGR) was re-elected Secretary/Treasurer and Sr. Kristy Slattery (CIU) was elected Vice-President. At this meeting I was elected as the LDAC delegate to the National PSAC Convention.

Members of our committee attended the Lethbridge and District and Labour Council General meetings in September, October and November and gave short verbal reports of PSAC latest activities including Phoenix, bargaining, and convention updates. Several members of the LDAC also attended a strategy meeting to help shape the next year of the Lethbridge and District Council. In September the Lethbridge and District Labour Council held an endorsement meeting for Lethbridge Municipal Election. In partnership with the CLC, endorsement cards were printed. I made sure all PSAC members received a copy of this card letting them know which candidates had a labour friendly platform.

On November 28<sup>th</sup>, I was called upon to give a media interview for Bridge City News (Lethbridge) regarding Bill 30: Alberta's new safety legislation including the right to refuse unsafe work, the right to know about unsafe work and the right to participate in Occupational Health and Safety Committees. <a href="https://www.youtube.com/watch?v=l-w81HacQvo">https://www.youtube.com/watch?v=l-w81HacQvo</a>

In November, members of the LDAC attended the Canadian Labour International Film Festival that was held at the Lethbridge Public Library. Two members of the LDAC were also in Ottawa for leadership training.

On December 8<sup>th</sup>, I lobbied Conservative MP Rachel Harder to discuss the ongoing Phoenix issues. I asked Ms. Harder to speak about Phoenix in the house and demand that the liberals hire more compensation representative region wide to help alleviate some the issues our member are facing. I advised if she doesn't speak to this issue in the house on our behalf we will have "Burnt by Phoenix Pizza Lunch" demonstrations outside her office on Feb 21<sup>st</sup>. Ms. Harder committed to requesting approval to speak in the on house on behalf of her constituents about Fixing Phoenix. She asked me to keep her in the loop regarding our day of action and could potentially speak at our rally.

This term I was also sworn into the Alberta Federation of Labour Executive Committee and Alberta Federation of Labour Council. I have attended two meetings for these committees, the first being in Calgary and the second being in Edmonton. At these meetings I present updates about PSAC, including our struggles and where we need labour allies within the province. I also become aware provincial and national labour campaigns.

Finally in January, the PSAC Lethbridge Regional Women's Committee hosted the first every Lethbridge Living Library. This event was in recognition of the second anniversary of the Women's March on Washington and Canada. The Lethbridge Living Library included various organizations (including PSAC) and speakers from within our community who serve the principles of human rights, social justice, equality, and compassion. I gave five media interviews leading up this event on CTV, Global, Bridge City News, and 95.5 Country FM.

This provided the opportunity to speak to MP's on Phoenix pay issues that members are experiencing and discuss the current items PSAC has identified as measures the government needs to take to react to the Phoenix pay fiasco.

#### Outreach

During the last reporting period I have attended and supported events within the region as well as WestMan Area Council events. This included several events from working the PSAC booth at the Brandon and Area Labour Day Picnic to assisting Locals with elections. Another event that stands out to me is attending the Transgender Day of Remembrance Vigil, this event was deeply moving and educational to myself. I continue to be available to all members and hope to be able to assist with issues as they arise.

#### **Future**

Looking forward unfortunately the one of the largest issues would be the Phoenix pay problems. With upcoming PSAC actions, events, and training on pay advocacy hopefully all members will continue to participate and we can push for some resolutions.
