The committee members assisted in facilitating the Prairie Region Caucus during the National Conference. Thanks to each and every member as they moderated the dialogue and collected the notes from each table during the Prairie Region Caucus meeting.

The Committee had an official meeting, via conference call, on January 16, 2020. The following actions took place:

- The notes from the Prairie Region Caucus were reviewed. They key highlight points were:
 - H&S education is needed
 - Networking
 - Access to H&S databases on the website
 - Basics of WCB processes to assist reps and members
- The Committee's Terms of Reference were amended to include a Secretary/Treasurer position for the committee. Jayne Fisher was the successful activist who got this position.
- A resolution was produced and debated by the committee and was submitted to PRC for consideration. We hope it will hit the Convention floor at the Prairie Region Triennial Convention in June 2020
- The Committee discussed with the Prairie Region Health & Safety Officer the possibility of moving the Regional Health & Safety Conference to be held during the first year after the Regional Triennial Convention rather than holding it during the third year.
