- Prairie Region will be holding Leadership Political Action Courses and it is being funded with additional money beyond our regular education budget. Many thanks to Prairies staff for pulling it together so quickly
- Is assigned PA and Common Issues bargaining tables. During the last couple of rounds, we have questioned if they have a mandate. Government is clearly stalling. We can't declare impasse until all demands are tabled. PSAC has no intention of stalling and will be moving to impasse as soon as possible if no tentative agreement is reached.
- Train finally pulled into Churchill again on October 31st

Questions:

- How many times have Teams met? Table specific have met three times and one time to caucus. Common Issues has met twice.
- What is the wage proposal? 3.75% per year for 4 years.
- Who will be invited to the PAC training? All PRC, all AC Exec members, 1 rep
 per each other committee, all National Bargaining team members from 5 tables
 and CFIA, Parks, CRA. It is a higher level leadership training. If Locals are
 looking for political action training, they should reach out to the Reps. The
 training is designed to be done by province but if leaders are not available, they
 will be allowed to go to another province. No alternates will be allowed.

Sr. Ahenakew advises that her call to action was to purchase TRC booklets with the 94 calls to action and share them with others. She provided one to each PRC member and additional ones to be sent back to each RO specifically to the HRC's where present.

We need to lobby provincial governments to change school curriculums. Copies of the Kairos petition for all three provinces provided.

Action: send out to the PRC the list of Treaty areas that Sr. Ahenakew sent to the REVP office.

(d) PSAC Education and Outreach – submitted by Michael Weisgerber

Br. Weisgerber says that he does outreach with his members to get them to a course and then it gets cancelled or postponed and then we lose them. He knows that the education review is underway but his members are frustrated.

Sr. Hladun advises that as Chair of the National Education Committee, regional education is part of the discussion at the national level. If PRC has any ideas, please send them to Br. Chan and cc Sr. Davis

Br. Little-Gagne says that the Education Committee will be looking at this and will send ideas to Br. Chan. They will discuss with the REO and bring back to the PRC.

(e) Opioid Crisis Book Launch – submitted by Krysty Munns

Sr. Munns thanks Sr. Hladun for supporting this book launch. She attended the June 30th book launch and funds from the event sent to the Sweetgrass Youth Alliance. She has brought a copy of the book for each RO.

(f) Here for Canada and Phoenix Update – submitted by Marianne Hladun

TV ads were strategically aired during national news and online social media. The video featuring Sr. Shannon Blum has popped up on people's newsfeed 5 million times and 1.5-2 million have watched all or a portion of it. Staff have been asked to show videos to members. Will continue to build on the campaign.

Escalating priority cases but they are getting bottlenecked. There is a 20 million deficit and discussions continue around damages. We need to mobilize members to shift from anger and frustration with the union to the employer. PRC were sent the lobbying kit and would like to see more actions from Area Councils in particular as funding is available. Please send in a plan and budget. Media is being handled through the REVP office and if you know anyone who would like to share a personal story let the office know.

(g) Membership Dues Change File – submitted Marianne Hladun

Br. Thomas Linner provided a presentation on the membership dues file change. PRC feels that there should be a wording change on the National website 'to equal to the value' to make it more clear.
