#### Resolution BL-003: Electronic Voting at Prairie Region Convention

m/s Glen Johnston and Don Wilkie:

That the Convention adopt the committee's recommendation of **concurrence** in Resolution BL-003 which reads as follows:

**BE IT RESOLVED THAT** Section 11 Sub-Section 3 (c) and Section 11 Sub-Section (5) (a) (i) be reworded to include the use of electronic voting where viable; and

#### **BE IT FURTHER RESOLVED THAT** the wording read as follows:

Section 11

Sub-Section (3)

(c) The election to the office of REVP and A/REVP shall be by secret ballot. Each voting delegate shall indicate by ballot the name of their choice for the office called, from among the nominees for office.

Section 11

Sub-Section (5)

Election Procedures for Prairie Region Council Representatives

(i) The elections shall be by secret ballot. Each voting delegate shall indicate by ballot the name of their choice for the office called, from among the nominees for office.

**BE IT FURTHER RESOLVED THAT** this change be enacted immediately to allow for electronic voting at the 2014 Prairie Region Convention.

#### **RATIONALE**

The Committee agrees that the immediate change to the Prairie Region By-Laws will allow for the use of electronic voting at this and Subsequent Prairie Region Conventions.

That the resolution be referred back to the Committee with the following instructions: that Section 11 (3) (c) and 11 (5) (i) be amended to read "... indicate by ballot or electronic voting the name...."

Sub-Section (7)

The Young Workers Representative shall:

- a) uphold and promote the mandate and objectives of the PRC:
- b) promote the establishment of Young Workers' Committees in the Prairie Region as outlined under Section 15 of the PSAC Constitution;
- c) communicate with Young Workers in the Prairie Region;
- d) attend PRC meetings and shall be the spokesperson for the Young Workers in the Prairie Region;
- e) Submit a written report of the representative's activities and those of the Young Workers' Committees, PRC meetings and the Prairie Region Triennial Convention;
- f) promote representation in groups who defend Young Workers' interests;
- g) serve on PRC Committees and perform other roles and responsibilities as determined by the PRC and/or the REVP.

**BE IT FURTHER RESOLVED THAT** all references to Prairie Region committees be updated to include the Young Workers' Committees.

**BE IT FURTHER RESOLVED THAT** any reformatting of numbering/bullets to reflect this change be carried out as needed.

#### **RATIONALE**

The Committee recognizes this is a change to the By-Laws to establish Young Workers' Committees within the Prairie Region in accordance with the PSAC Constitution, Section 15.

#### MOTION OF CONCURRENCE IN RESOLUTION BL-002 CARRIED

#### Composite Resolution BL-011A: Membership Rights

m/s Glen Johnston and Don Wilkie:

That the Convention adopt the committee's recommendation of **concurrence** in Composite Resolution BL-011A which reads as follows:

**BE IT RESOLVED THAT** Section 4, Sub-Section 2 (a) of the Prairie Region Bylaws be amended to read:

to be free from any act or omission on the part of the Prairie Region members that would discriminate against the member on the basis of age, sex, colour, national or ethnic origin, race, religion, marital status, family status, criminal record, physical or mental disability, sexual orientation, gender identity or expression, language, political belief, social and economic class or employer; and

**BE IT RESOLVED THAT** all references of 'gender identity' in the **PSAC Prairie By-Laws** be replaced with 'gender identity <u>or expression</u>' and any formatting of numbering/bullets be carried out as needed; and

**BE IT FURTHER RESOLVED THAT** the PSAC Constitution **Section 5**, **Membership Rights**, **Sub-Section (b)** be amended to read as follows:

#### Sub-Section (b)

to be free from any act or omission on the part of the union, or other members, that would discriminate against the member on the basis of age, sex, colour, national or ethnic origin, race, religion, marital status, family status, criminal record, physical or mental disability, sexual orientation, gender identity **or expression**, language, political belief, social and economic class or employer; and

**BE IT FURTHER RESOLVED THAT** all references of 'gender identity' be replaced with 'gender identity or expression' elsewhere in the PSAC Constitution, website or reference materials.

#### **RATIONALE**

To bring the Prairie Region By-laws in line with the PSAC harassment statement and to ensure this is addressed at the 2015 PSAC National Convention.

# GREETINGS: LARRY HUBICH, SASKATCHEWAN FEDERATION OF LABOUR PRESIDENT

Sister Nancy Johnson introduced guest speaker, Larry Hubich.

Brother Larry Hubich advised that the Saskatchewan Federation of Labour (SFL) represents over 100,000 members.

There are currently 23,000 PSAC members in the region that protect our way of life. The membership is diverse. The current federal government wants to weaken our organization and is intent on attacking your union. This has been the theme across the country. Governments attack unions because they think economy does better when

unions do not exist. When the truth is that society and the economy actually do better when employees have a voice through their unions.

In the 1970s, job rate was better due to much union involvement and membership. Best growing economy. Most advanced Health and Safety legislation. Unprecedented period of prosperity. Union activism will not stall our economy – it's just not true.

It is the working people across Canada that have made the country what it is today. Built the middle-class through collective bargaining. It's not the other way around.

Sister Hladun thanked Brother Hubich and, as a token of appreciation, offered a donation to the SFL Summer Camp.

# ADDRESS: BARBARA BYERS, CANADIAN LABOUR CONGRESS SECRETARY-TREASURER

Sister Hladun introduced Sister Barbara Byers.

Sister Barbara Byers offered greetings to the delegation from 3.3 million members of the Canadian Labour Congress (CLC) and CLC staff. She also acknowledged the work of national leaders and delegates here in the region. CLC looks forward to working with the PSAC against the Harper government. The labour movement is being challenged, but we will work together. We need all of our resources to do it. We need to build our membership and reach out to the general public. We must put emphasis on what unions do for members and for citizens of this country.

At the CLC Convention, members agreed to push-back against a government that seeks to strip away rights regarding legislative protections.

The right-wing government and employer groups are attacking members and citizens' rights; to weaken the union's ability to fight back.

We must take labour on the offensive to defeat Stephen Harper and his right-wing government. That is our goal.

Harper especially focused his assault on public service workers. Attacking pension plans and sick leave. We must ensure that Harper knows that we are going to stand up and fight.

We are at a critical juncture. If we don't fight back - our unions, our movement, our country - will be changed forever. It's that serious.

At the CLC Convention, a resolution was passed, it is the "Together Fairness Works" campaign. The ads, which reflect core Canadian values, have been popular with the membership and the general public. They have instilled pride in our membership. Proud members are our best messengers. The "Sunny" ads have reached over 10 million people.

Of Canadians, 30% are on our side; 20% are not really into unions, and the rest are non-partisan.

We have to continue to explain what unions have done for members and for Canada. Union members earn more - \$5 more; and if you are a woman in a union you make \$6 more as a union member.

We have to tie unions to the value of fairness and switch the public's view of unions.

When we fight for rights, we are fighting on behalf of ALL Canadians. We have to be visible.

Labour Day will be a day for our activists to build engagement with their co-workers, families and communities. So they know what a great labour movement they are a part of.

Pensions: Canadians can't save enough for retirement and workplace pensions are under attack. The best defense is to fight for a good Canada Pension Plan for everybody. Harper wants people to invest in defined contribution plans which means you take the risk. Seniors are living in poverty. We need to have an increase in Canada Pension. Retirement, security and dignity for all retirees.

Childcare: We need to keep on having this conversation. Why is there only one province that has \$7 per day childcare?

The message from the CLC is as follows: We will work with you when you are working on behalf of workers and on behalf of citizens. If any government chooses to attack us we will fight back, mobilize and build solidarity.

The Committee recognizes the importance of the PSAC Social Justice Fund demand, however believes that the voice of the members through their bargaining demands should prevail if going into a dispute resolution process.

### Address: Marianne Hladun

By a show of hands, how many were at Convention in 2011 in Winnipeg?

In some ways, we're in a very different place than we were just three years ago.

- The federal government has cut billions of dollars from public services and thousands of federal government jobs.
- We've lost over 3,000 members in the Prairies due to federal budget cuts and workforce adjustment.
- The attack on the labour movement has been relentless with malicious antilabour legislation such as Bill C-377, Bill C-525 and Bill C-4.

Then again, in other ways, something things haven't changed.

- In 2011, we rallied with postal workers at Convention calling on Canada Post to respect workers.
  - This time, we're fighting Canada Post on their decision to stop door-to-door delivery and to cut 8,000 jobs in the process.
- In 2011, our members stood our ground in the face of a concerted campaign to erode the pension rights of our members in the public sector.
  - Now, we're fighting the Conservative government's plan to strip away sick leave rights and contract out the management of the sick leave system.
- In 2011, Harper had just won a majority government and was \( \mathbb{e}\) ager to use the power for evil.

Three years later and, well, we all know how that's turned out.

But there's a silver lining to all of this: Union members are fed up, Canadians have had enough, and we're all ready to fight back—together.

That work has already begun.

Member by member.

Local by local.

Area by area.

The We Are All Affected campaign is a perfect example of this.

It forms the foundation of the way we do business: talking to our members, talking to our friends and family, talking to politicians and the media.

I look forward to seeing the campaign continue and to having the face-to-face discussions that are critical to the success of our union, both at the bargaining table and at the ballot box during the next federal election.

We're communicating more effectively.

Our telephone town hall events have been one of the most successful examples of this.

These events were started right here in the Prairies and have now been done by every other region within PSAC on various important issues.

We're taking to the streets.

Last year hundreds of members and activists gathered in blizzard conditions to protest the Conservative's Convention and their impaired judgment and reckless policies.

And that's just one example, look at the mobilization around the National Days of Action, or the cuts to Veterans Affairs, or the community rallies protesting backwards provincial and municipal policies.

We're active in our communities.

By working together with community groups we were able to achieve an historic win in Saskatchewan that will set a precedent across the country.

The Sask Party unanimously passed an opposition bill to make reporting of asbestos in public buildings mandatory.

This is something that our friend Brother Howard Willems fought tirelessly for and something PSAC was proud to keep fighting for on his behalf.

We've also built bridges with Indigenous communities through our work with Idle No More, the fightback against the privatization of the Canadian Rockies Hot Springs, and relief efforts during the disastrous southern Alberta flooding last summer.

But, perhaps most importantly, we're talking to each other.

I have attended each of the multi-local meetings across the region over the past two months and the participation and discussion has been both exciting and encouraging.

We're sharing ideas, stories and experiences so that we can learn from our mistakes, build on our successes and plan for the future.

That was the whole premise of the Prairies Video Project.

Never before have we collected and shared members' stories in such an intimate and compelling way.

I was lucky enough to be on location for the interviews across the Prairies and to speak with these members first hand.

I'm delighted that everyone can share in the insights and experiences that these members shared with us.

The project has also received national recognition when it was awarded the Canadian Association of Labour Media award for "Best narrative video, or video series documentary".

Each video will be an important resource for us to teach members about our history and build solidarity.

The project showcases the power of collective bargaining, the importance of human rights, the reason we do what we do, and so much more.

We're going to show a trailer for the video project immediately following my address.

Throughout the weekend, we'll also be screening short two-to-three minute clips with excerpts from the 42 interviews and 2,500 minutes of footage we collected.

It's critical that we tell these stories both to archive our history, but also to help the next generation of activists just starting out their careers.

Our region has always fostered young workers.

It was young workers from the Prairies who put the resolution forward at the 2012 PSAC National Convention to create regional young workers committees.

Since then we held a series of meetings, which attracted dozens of young workers to network and strategize.

Next, we'll host the Prairies Conference for Young Workers from September 22-24 to continue this work.

At the same time we'll hold the Prairies Conference for Separate Employers and Directly Chartered Locals.

The conference comes at a time when we've organized seven new bargaining units, including three new directly chartered locals over the past few years.

We've certainly come a long way with the work we've done to mobilize members and build capacity.

But there's more work to do.

Let's continue to build on the momentum and keep moving forward.

Our priorities must be to defend collective agreements, defend public services and work towards the defeat of the Conservative government in the next federal election.

It's all hands on deck at this point. I look forward to working together with you to ensure a brighter future for our members, the labour movement, and all Canadians.

# Speech to the PSAC PRAIRIES REGIONAL CONVENTION

by Robyn Benson, National President Saskatoon, Saskatchewan June 2014

Sisters and Brothers, it is so great to be here with you here in Saskatoon for the last of PSAC's seven Regional Conventions.

You know the Prairies is my home and I am so moved and honoured to be attending this Convention as a delegate once again, and for the very first time as your National President.

All of the debates and decisions we make at conventions help shape the future of our union. The direction we take – how we move forward – is in your hands.

You are the leaders who are in the best place to set our course.

You represent the rank and file.

You work with members day in and day out, and you give voice to their issues and concerns.

**You** are important leaders in our great union, and I want to thank you for all that you do.

This is a critical time for PSAC members in the Prairies and across the country. Our jobs are on the line, and so are our working conditions.

The rights that we have won through years and years of mobilization, legal action and sheer determination are being stripped away.

Pay equity. Employment equity. Fair wages. Pensions. Health benefits. Social security. They are all under attack.

And, sisters and brothers, it's our job to turn things around, not just for ourselves and our families but for all the generations of workers to come.

This is the time to draw the line in the sand.

Now more than ever we have to say NO to every government and every employer that tries to take away what is rightfully ours.

Now is the time for us to move forward, not backward – united as a union, united with other unions, and united with all Canadians. Because together we can make our country a better place.

The next few years will be a big test for us, but we will succeed.

The threats ahead are enormous. But we also have opportunities.

First, we are starting to see cracks in Canadian Conservative landscape.

The late Jim Flaherty's sudden break from Stephen Harper on income-splitting was an important sign that things are starting to shift.

Then in the last few days, we have finally seen a move to change the temporary foreign worker program. Even Jason Kenney has been forced to admit that a better strategy for dealing with labour shortages is to raise wages.

But there are other signs that the Conservatives hold on Canada is weakening.

Consider Dimitri Soudas, Nigel Wright, Mike Duffy, Pamela Wallin.

Consider the robo-call scandals.

Consider what the courts have said about the Conservatives' so called "tough-on-crime" laws.

Consider the fact that the Supreme justices had to slap Harper for not following the law when he handpicked his Québec nominee to the Court.

Even the Conservative-controlled Senate is moving away from Stephen Harper's agenda.

In a huge labour movement victory, it looks like Bill C-377 won't be going back to the House of Commons any time soon.

This is the private member's bill that would have required unions to spend hundreds of hours reporting on our expenses to the Canada Revenue Agency.

These are hundreds of hours that are much better spent defending and representing our members.

We also just received word that Bill C-525 is delayed for now in the Senate, and that we have won some time to fight against it.

This is another piece of anti-union legislation that will make it much more difficult for workers in the federal sector to get unionized, and much easier for unions to be decertified.

The federal Conservatives are feeling the pressure of public anger. More and more people are saying enough is enough.

They are fed up with the billions of dollars going to tax breaks for the wealthiest, while billions of dollars are being cut from public services.

Canadians are worried about the future, and especially about the future of their children and their grandchildren. And for good reason! Youth unemployment has never been higher. Employment Insurance benefits are almost impossible to get. And younger workers are going to have to work much longer to qualify for Old Age Security.

The fact is that Canadians are sick and tired of bad government in Parliament. They have had enough of scandals, the backroom deals, and the bullying tactics of those in power.

Canadians want their country back.

And PSAC members and leaders can be proud of the role we've played in turning public opinion against the Conservatives.

Here in the Prairies, you have helped expose the damage being done.

Working hand-in-hand with the Components in the region, you have put the spotlight on the impact of the federal government's budget cuts.

Thanks to you, the voters in this region know about Service Canada cuts that have meant longer times for processing El cuts. Thanks to you, the people of this region are better informed about the cuts to border services, the cuts to National Defence and at Parks Canada.

You were on the front lines here in Saskatchewan mobilizing against the Closing of the Prairie Farm Rehabilitation Administration.

And across the region, you have helped explain the devastating impact of the many other program cuts at Agriculture Canada, including the shut down of the Prairie Shelterbelt Program and the Community Pasture Program.

Marianne and your Regional Council are leading the mobilization in this region with new energy and dedication.

You've given voice to PSAC members, and shown the public the faces of those who deliver services, through your award-winning video project. We win public support when we give members a chance to tell their own stories about the important work we do.

You've been on the front-line with veterans, demanding that the Harper government start giving them respect, dignity and honour for their service to Canada.

You've been marching hand-in-hand with Aboriginal and First Nations' communities and the Idle No More movement demanding that governments respect the rights of the Indigenous peoples of this region.

Your efforts have given the PSAC unprecedented visibility. And I know you are committed and determined to do more.

Because the harder we fight, the stronger we get.

And we are getting stronger, sisters and brothers. And we are also winning.

When we fought back against the closures of the veterans' offices, we won the support and respect of millions of Canadians. The issue made headline news for weeks.

When we forced Treasury Board to respect the negotiated Work Force Adjustment language in our collective agreements, including the right to alternation, we won jobs for hundreds of members who would otherwise have been thrown out of work.

We won pay equity for Canada Post workers ending a battle that lasted more than 30 years, and that put 250 million dollars in the hands of members.

When Treasury Board tried to put in place its new pay in arrears system, we fought back, and we won. No government employees' pay will be clawed back as originally planned.

In a precedent-setting case, we won Fiona Johnstone's right to work set shifts so that she could have access to day care.

And with that win, every Canadian worker can now argue for accommodation in order to meet family responsibilities.

Every one of these victories has made us better organized, more credible, and better prepared to fight on other fronts. And, that's good, because we have big fights coming soon at the bargaining table.

In just over a week's time, the largest round of collective bargaining in Canada will get underway when the PSAC sits down across from the federal Treasury Board to negotiate agreements on behalf of more than 120,000 federal workers.

Let's be clear. Treasury Board is going to do everything it can to break our union and weaken our contracts.

The Harper government wants to lower the working conditions and wages of all workers across the land, and it is going to try to use this round of bargaining to set an example for other employers.

That is why this upcoming round is everyone's business. We all have a stake in mobilizing around these negotiations.

And if we fight back against the attack – all of us in this room, alongside every PSAC member from coast to coast to coast – we will set the example of what unions everywhere can still achieve.

Our strategy for taking on this epic battle is straightforward.

We are organizing a massive and powerful force of resistance.

We are building solidarity with other unions.

And we are building strong public support by showing that this fight is not only about us, but about all Canadians.

The "We are all affected" campaign has already shown thousands of Canadians just how badly this government has been managing their services.

And in the coming months, we are going to continue this work by strengthening our campaign to stop the cuts to Employment Insurance and by fighting back against the cuts to home delivery of mail by Canada Post.

Through these campaigns, we will win allies and supporters. And this stronger solidarity will help us achieve better collective agreements, as well as better public services.

It is the way forward.

The more united we are, the stronger we are.

Through the PSAC's leadership, we have united federal public sector unions under one roof and signed a historic solidarity pact for the upcoming negotiations with Treasury Board. This is a bold and unprecedented move.

The most important piece of our strategy is right here in this room. **You**, the front-line leaders.

It starts with every local being eager, energized and prepared.

I know many of you are already talking to your members and many have been collecting signed pledge cards in support of our collective agreements and public services. I am proud to report that we have reached out to more than 30,000 members who have pledged to do their part to defend public services and workers' rights.

But we need to do much more to engage our members. We need to organize concrete actions.

Over the coming months, we will be identifying strategic targets.

Workers in some worksites may walk off the job at lunch time for 19 minutes, as they have been doing in the province of Québec for the past three months.

And some may take even bolder action.

The decisions on what to do will be in your hands. The most important thing is that whatever you decide, it has to be a success. We have to show that we are strong and organized.

That's why we aren't going to try to bring all members out at the same time and ask them to do the same thing—at least not just yet.

We are starting slow but steady so that we can get better and better organized and get ready to take bold cross-country action when we need to, with other unions supporting us, and with the public on our side.

That, sisters and brothers, is how we are going to defend our collective agreements. That's how we will make gains.

Our locals are where the work needs to take place.

As front-line activists, you are leading this charge, and although I know you bear many responsibilities, let me stress this as clearly as I can. Mobilizing our locals is the most important, crucial job you must accomplish.

Our success as a national union depends on our locals being ready for the challenge.

You, your officers and stewards play a critical role in engaging our members, coworkers, friends, neighbours and communities.

Where you sense apathy and demobilization, you need to intervene.

You need to communicate our story and convince people around you of the value and the importance of this fight. You need to convince others that this fight is everyone's fight.

We have to rally together and push in the same direction, whether we are talking about Components, DCLs, Regional Councils, Area Councils, Committees – everyone.

We need to make this commitment. And we need to follow through.

As your National President, my pledge to you is constant and unwavering support. I will work with you, stay connected to you, and support you in any way that is needed.

Sisters and Brothers, I say again, we are at a critical time.

We are living in a time of right-wing governments. They have a single goal.

They want to set our country back 40 years.

They want to destroy the hard-earned commitments that generations of Canadians have fought for and achieved over many decades.

Commitments like social programs and public services. Commitments that take shape every day through the hard work of public service workers.

**We** fought for these public services and the values that underline them. **We** fought for prosperity and wealth to be shared and benefit all.

We fought for more equality and opportunity.

We fought for progressive and fair taxation, social programs and access to heath care and education.

We fought for decent wages.

And

We fought for the right to express ourselves, to organize ourselves and to bargain collectively.

These services, these values, these commitments were not handed to us on a silver platter. We fought to establish them, and to make them a reality in this country.

And we will fight just as hard to keep them.

They think that they can rip apart what holds us together. They believe they can impose more inequality, more wealth concentration, more inequity and more violence on us.

Front-line leaders, as unions, we have a choice to make.

We can either roll over or put up a fight.

We can accommodate this destruction or refuse it entirely.

Ask yourselves why the Conservative government is so intent on attacking us?

It attacks us because we protect the promise that our society holds and the foundations on which it stands. To put it more bluntly, they attack us because they recognize our power.

They know we are a force to contend with. And they know we have the people, the resources and the power to defeat them.

Brothers and Sisters, it's time to use that power.

It's time to stand together and fight. Sick leave claw back? We say **no**!

Roll back of pay equity gains? We say no!

Performance management as a new termination tool? We say no!

Privatization of public services? We say no!

Unilateral moves on labour laws and right to work? We say no!

And instead we say **yes** to getting our country back.

With the help of a strong Prairies Region, **we** will continue to build a better union for our members.

We will get the membership mobilized from the locals on up and ready for action.

We will not bow down to the threat of back-to-work legislation.

We will sign fair and decent collective agreements.

We will continue to fight the Conservative agenda, and replace it with one that meets the very real needs of all Canadians.

Due to Sister Robyn's move, the Alternate REVP (Regional Executive Vice President) position became vacant in the Prairie Region. I was nominated, and successful in being elected. I have been honored to represent all of you. Thank you for your support, and the opportunity.

I was sworn into this position on October 12, 2012 at my first Prairie Region Council meeting in Regina, Saskatchewan. I have now been in

this role for approximately 2 years, and I can honestly say – what an eye opening experience. I could now tell you what I've done for the region in my role as Alternate REVP for the Prairies, and include things like I spoke at town halls, on the news, rally's, attended every PSAC meeting I could, attended the day of action, I chaired the communications committee, I participated in the bylaw committees and chaired mock conventions.... and I could give you details surrounding that, but... I say this, because, I believe currently, our political environment is a mess. You will see by our slogan of this years convention – "Our Union: Bringing Us Together" is a direct reflection of the current political environment. We all know that the fight against the politics of our business is going to be long and hard. We know that with the current environment we will certainly be facing a challenge. We, the Prairie Region have an opportunity to start change now, and then well into 2015. We need to stand together!

Where to start? We have Bill 377, and Bill C4. Both bills are a nightmare for our Union. Then of course we have bargaining happening with a government that isn't exactly PRO anything for Public Service Employees. I would at this time like to say "thank you" to our bargaining teams for all the hard work they are doing for all of us! Now, this report was due mid May 2014. Did you read the entire documents? Could you? Do you have enough time? I think that we, the Prairie Region, need to do a better job of making it easy. When new, important legislation is on the horizon – information needs to go out as soon as possible to all the Prairie Region Council members and then to the delegates here and locals across the region. If we make it a short document, with the quick and accurate facts, it's easier to remember, and easier to distribute.

With the recent decision about desk drops — I think we have to try whatever possible to provide the information. I am sure some of you are thinking — but what about the financial cost? My question is what is the 'cost' to us as a Union if we don't? What is the value of getting one more person involved? Had it not been for my local president at the time, Lois Greenhalgh, taking the time to educate and speak with me I would not be involved. Have I made a difference? Has Lois? I would like to think so. The fact is though — many of us here have full time jobs, we all (or should be able to) have personal lives... we all give a lot to this union — which is fantastic, but... how do we make it easier? We also are working on GLBT information pamphlet (due out soon!) that would include many aspects of the GLBT struggles from the past to present to show our members a complete snapshot of the good work that our GLBT members/staff are working towards. The frustrating part of being part of this committee is that we have not met face to face since 2010, but we have been able to keep up during several conference calls. Not meeting face to face has been a

barrier to completing the Human Rights work we set out to complete as a committee, hopefully this will be rectified during the fall 2014 meeting of the whole committee (Women's, Aboriginal, Racially Visible, GLBT and Persons with Disabilities). I would also like to say thank you to the national PSAC staff who worked on our files as they are also wonderful to work with, some hurdles have been overcome and others are still in the works. Always moving forward – never back!

This was also a trying time in the Prairies with all of the worthwhile campaigns (We Are All Affected, Pensions, etc.) that were happening and mother nature did not help either! The flooding in Calgary during the summer of 2013 was unprecedented. Many of our union activities were put on hold and many PSAC members were faced with utter devastation as their homes became uninhabitable. With the help of the Social Justice Fund (PSAC) we were able to fund some of the Human Rights charities we have worked with in the past. We also were able to rally together members from many different locals on two separate events at the Drop-In Centre and the Mustard Seed to prepare and plate over 1,200 meals. These members came from Saskatoon, Lethbridge, Winnipeg and Edmonton and included our REVP (Marianne). I am proud of this because most PSAC members in other locals rarely interact with one another, but this was in the name of charitable work and our members are always ready to volunteer. For those who did volunteered, and you know who you are, an extended thank you from myself.

To all of my Brothers and Sisters in the Prairies, I say "thank you" and praise you all for coming forward in the name of our union. Please find below a select amount of achievements I enjoyed while being your representative on the Prairie Region Council.



"The coin that Taxali is most proud of is the wedding-themed coin, featuring two intertwining rings that represent a gender-neutral marriage. "I live in a country where gender is irrelevant and the coin has to represent that," says Taxali. "I thought it would be a nice thing to represent that and to show two rings; is one a man and one a woman? Two men? Two women? It doesn't matter what they are, they represent the union of two people. "The Royal Mint really liked that idea because it represents the spirit of our nation and also, I think that it's empowering to somebody and hopefully this calling will send a powerful message that we're all the same and a wedding is a wedding. I think this is probably the first piece of currency in the world, paid by a federal government that is pro-wedding regardless of gender and that makes me really happy...."



There was also uniformed CBSA officers and Calgary Police Service officers walking in the parade with Agency approval. Also in attendance was Ron Moran, 4th VP of CIU.



#### May 24th to June 01st

Fairy Tales Film Festival – The PSAC/CLC/AFL sponsored a night at the festival with two powerful films "Call Me Kuchu" a drama based on human rights in Africa and "Parade" an eastern-European film based on the events leading up to the parade in Belgrade in 2011.

The three members of our committee spoke on 1) creating harassment free workplaces 2) jobs within the municipal, provincial and federal levels for the GLBT youth 3) creating links between our jobs and community at large – ie. Volunteering or mentoring others. We were also honoured again with the silver level sponsorship as the three unions donated \$3,000 for the festival, up \$2,000 from the year before. With our Social Justice money we were able to sponsor a \$1,000 roast beef dinner for over 400+ residents of the ministry. We also had '15' PSAC volunteers preparing and serving the dinners. A tour of the facility was also given to show the volunteers what other services the ministry had to offer (ie. Storage lockers for all their worldly possesions while they went to find work)



### GlobalFest 2013: August 16 to 25

I opened a panel on discussions about racial discrimination in the GLBT community at the Glenbow Museum. We also volunteered with our Calgary Human Rights Committee and Area Council along with our Brothers & Sisters from UFCW at the festival. Globalfest's theme this year was aboriginal issues. There was 100 new Canadians sworn in during this ceremony.



### Sunday - September 01st

Participated in the 22nd annual Calgary Pride Parade.

Three Mounties were sighted this year at the festivities, trying to get more law enforcement personnel to attend the parade. The Calgary Human Rights Committee to send letters to our law enforcement



### November 18th - 22nd - National Human Rights Conference

First time ever all the five equity groups met in Toronto for this "mega conference". Lots of things worked, some didn't, timing was a luxury. Great speakers, again not enough time. 

#### **Communications Committee**

On behalf of the Communications Committee, I would like to thank our advisor, Jeffrey Vallis, Communications Officer for the Prairie Region for all of his assistance with this committee. I would also like to thank all the committee members for their time, dedication and service to the committee and the Prairie Region.

Over the last three years, the Communications Committee tackled some large projects, including the creation of a new logo for the Prairie Region, determining what type of materials/ products/ "swag" would be useful to PSAC Prairie Region members and the Prairie Voice Award.

Of note, the Communications Committee needed to determine a theme for our 6th Triennial Convention. The theme – "Our Union: Bringing us Together". Was a theme we picked for many reasons. Ultimately – it is about solidarity. Here is the excerpt explaining why: The theme, "Our Union: Bringing Us Together", is about members standing together in this difficult political climate we are faced with across Local, Component and Provincial lines. At a time when workers are under attack at all levels including federal, provincial, municipal, public sector and private sector, the theme for the 6th Triennial Convention of the PSAC Prairie Region reminds us that we must all speak with a strong, unified voice and continue to work together because we are all affected.

For the logo – it was determined in 2011 all regions within the PSAC converted to the nationally-branded cogs to allow for a uniform identity and easy public recognition of our union. However, most regions complement it with an individual identity that represents the region and its members.

The logo was voted on and chosen as the new Prairie Region Logo at a recent PRC meeting. For me, when I look at this logo, I see a fresh new outlook that's still firmly based in tradition. The three stalks of wheat represent each individual province bundled together to show our solidarity. The richness of the gold is indicative of the rich landscapes across the Prairies, while the darker colour represents our strong, unwavering spirits. For the Prairie Voice Awards, nominations were to be accepted for the following areas: Community Outreach, Human Rights, Initiative/Leadership, Labour Award, Mentor, Political Action, and Steward of the Year. At the time of this report, I am unaware of who was nominated, and/ or who the successful PSAC members were. However, the committee would like to congratulate all of the nominees and recipients at this time.

Lastly, I would also like to add a small note about the Prairie Region Video Project. Although the communications committee was not responsible for this project, I feel that it needs to be mentioned within this report as the videos greatly impacted communications within the region. In spring of 2014 a refresher course was delivered to our existing Alliance Facilitators to re-enforce their skills and encourage the Facilitators to put their knowledge to good use. Also, several of our alliance facilitators were given the opportunity to co-present information for the Committee training sessions held in April and May. 21, 14

# The PSAC Prairie region, at a glance ...

- Our region is made up of more than 22,800 members from Manitoba, Saskatchewan and Alberta.
- 210 Locals carry out the day-to-day work of the PSAC in the Prairie region.
  Our Locals range in size from eight members to more than 3,000 members,
  including four Directly Chartered Locals. Our members come from a variety
  of workplaces and employers, including the Federal government and
  agencies, airports, crown corporations, Casino Regina, and newly organized
  members at the Universities of Winnipeg and Brandon, the Canadian
  Museum of Human Rights, and the Centre for Aboriginal Human Resource
  Development.
- The five PSAC Regional Offices (Winnipeg, Saskatoon, Regina, Edmonton and Calgary) and a staff of 25 support the work of the PSAC in the region.
- Prairies members are represented by the 24-member Prairie Region Council
  headed by Sister Marianne Hladun, the Regional Executive Vice-President
  for the PSAC Prairie Region. There are also eight Area Councils, eight
  Regional Women's Committees, four Human Rights Committees and one
  Regional Aboriginal Peoples Circle in the Prairies.
- The Prairie Region education program is under the leadership of the Prairie Region Council (PRC) Education Committee which consists of David Fandrich (Chairperson), Tim Hogan, Shaun Brennand, Alex George, and Judy Shannon (staff Regional Education Officer).

# Developing the regional education plan ...

In October, 2012 the PRC Education Committee met to discuss the 2013 -2015 Regional Education Plan. Before designing the plan, the committee wanted to have a broad consultation with members in the region and decided on three tools to achieve that goal:

- 1. The first tool was an on-line membership survey open for the month of November, in which members were asked questions about their union activism, their workplace issues, and what type of education would meet their needs as members, stewards or leaders in the union. More than 100 members participated in the survey and their responses have been incorporated into this regional education plan.
- 2. The second tool was a series of education planning meetings across the region. There were 8 meetings, held in Winnipeg, Brandon, Prince Albert, Saskatoon, Regina, Edmonton, Calgary and Lethbridge. The 69 meeting participants discussed the purpose of union education and emerging education needs and their ideas have also been incorporated into this regional education plan.
- 3. The third tool was direct communication with a member of the PRC education committee, either by phone, in person or via e-mail. Ideas and responses from those who chose this route have also been incorporated into this plan.

A draft version of this plan was circulated, for feedback, to members who participated in the education planning meetings and the education survey, as well as to the Prairie Region Council, PSAC Prairies Local Presidents, component national officers, chairpersons of area councils and committees, Alliance Facilitators (AFs) and AF candidates, and PSAC Prairies staff.

Subsequently, the plan was presented to the Prairie Region Council and approved by Sister Marianne Hladun, PSAC Prairies Regional Executive Vice-President in April, 2013.

The Prairie Region Council Education Committee is confident that this Regional Education Plan will provide direction for the development of regional office education schedules and other education initiatives, and that it will also be flexible enough to respond to emerging issues over the next three years.

# The purpose of union education is ...

One of the questions discussed at the regional education meetings was "what is the purpose of union education". The main themes that emerged from that discussion will serve as the focus of the 2013 -2015 Prairies Regional Education Plan:

- Union education helps members understand their rights, which in turn empowers members at the workplace.
- Union education builds the union by engaging and informing members.
   Educated members are more likely to become active members.
- Union education provides a place for members to network and learn from one another.
- Union education brings a deeper understanding of the value the Union brings to our members' lives.
- Union education helps us build for the future. It appreciates our past and our present, supports emerging leaders, sparks action for change, and is a safe place to talk about controversial and contentious issues.

# Strengthening the education basics with new ideas and initiatives ...

Over the last three years (2010 - 2012) there was an increased membership involvement in the regional education program by almost 20% and we want to continue that trend. This cycle we will explore a variety of methods to make our education program more accessible, including:

- e-learning
- web-i-nars
- Alliance Facilitator-led education events
- Regional office and rural area courses
- education forums
- · region-wide advanced training

Effective January 1, 2013 the per diem for members to attend a PSAC course was increased from \$25 to \$50 for full days (for those members not in travel status) which should ensure that no member is "out of pocket" while attending an education event.

The PRC Education Committee will continue its' consultation throughout the three years of this education plan, to ensure that the plan continues to meet the needs of PSAC Prairies members.

<sup>&</sup>lt;sup>1</sup> This line item supports Alliance Facilitators with training and skill development, preparation and research time, and out-of-pocket costs associated with facilitating at education events. The Prairie Region Council Education Committee will carry out a comprehensive review of our Alliance Facilitator program to better respond to the needs of our members.

<sup>2</sup> Regional Offices schedule education events for members in their sub-regions, based on this Education Plan. The determination of which courses to offer, when, and how are based on the ongoing consultations with union leaders and members in the five sub-regions.

### **Health and Safety Committee**

The work of this committee has had it's challenges, though it has also been a fufilling experience, and the committee is proud of the work it has done over the past three years.

There has been much change in the committee itself in the last three years. The original committee consisted of Gloria Kelly (South East MB), Nancy Johnson (RWC Representative) and Alec Goertzen (Calgary Area Council Representative). Gloria stepped down from the Prairie Region Council and Clint Wirth took her place as the South East Manitoba Representative, and the Manitoba representative on the committee. In June 2013, the PSAC Regional Representative responsible for the committee, Bruce Campbell, retired. The committee wishes him all the best in his future endeavours. On December 2, 2013 Clint resigned from the committee to work for the PSAC in the position of Regional Representative- Health and Safety, leaving the committee without a chair. Welcome to the new Manitoba representative on the committee, Gus Mardli. Most recently, Alec Goertzen stepped aside from the committee and we thank him for all his hard work and dedication.

Through all of these changes, the committee members have taken many opportunities to fulfill the work of the committee. The committee has met face to face on many occasions, but have also held conference calls throughout this time to coordinate and plan the activities of the committee. The committee has taken on many iniatives to promote health and safety, as well as create awareness of current issues. Some of the highlights of the committee's work are listed.

### 2012 Prairie Region Health and Safety Conference

The 2012 Prairies Regional Health & Safety Conference was held on November 17-18 in Edmonton. The conference was attended by 46 delegates and focused on mental health in the workplace, with particular attention to the impact, recognition, and prevention of bullying. The committee was responsible for the majority of the conference, playing a large role in the organizing of the conference, including planning, agenda items, registration, delivery of workshop sessions, and various hosting duties.

Months of planning and hard work by committee members lead to a successful and productive conference. Feedback from participants was very positive, and the information provided during the conference was timely and useful to the delegates. A complete conference report is available on the Prairies website.

Guest speakers included Sjors Reijers, Manager for program Promotions at Mental Health Commission of Canada presented on the Mental Health First Aid (MHFA) program. "The priorities are to decrease stigma, raise awareness and provide first aid for mental health incidents", he explained. MHFA is the help provided to a person developing a mental health problem or experiencing a mental health crisis. Just as physical first aid administerd to an injured person before medical treatment can be obtained, MHFA is given until appropriate treatment is found or until the crisis is resolved.

In the afternoon session, delegates participated in a series of workshops around the overall theme of mental health in the workplace, including Representing Members with Mental Illness, Balancing Life & Work, and Regulation 20: Violence Prevention in the Workplace. Together, members planned for continued discussions, education, networking to move health and safety work forward and to ensure workers return home every day safe and healthy.

The first part of day two was dedicated to asbestos awareness and Howard Willems, a retired PSAC member and dedicated activist, who was diagnosed with mesothelioma, an asbestos related cancer of the lungs. Howard succumbed to the illness the week prior to the H&S Conference.

Denis St. Jean, PSAC National Health and Safety Officer, made a presentation on the history of asbestos, and PSAC's asbestos resolution. REVP Marianne Hladun followed by giving a presentation on behalf of the Saskatchewan Asbestos Disease Awareness Organization (SADAO). Bruce Campbell PSAC Health and Safety Representative closed this segment with an explanation of issues that were previously encountered in Winnipeg and how they were addressed. After the break, delegates got into groups to discuss their expectations for the future and what tools they need to assist them in moving forward with their health and safety work.

Documents provided to delegates, discussed in workshops and presented throughout the conference are available for download on the PSAC website.

### **Day of Mourning**

Each April 28 is recognized as the National Day of Mourning. On this day, candlelight vigils and walks are held throughout the prairies. On this day we recognize those that have lost their lives, or have been seriously affected by workplace injuries, such as family and coworkers. This day is also a day of call to action, to ensure no one ever has to feel a loss due to a workplace injury.

Each year, the H&S committee prepares a letter outlining the goals of this day, as well as highlighting some current issues in health and safety. We also participate in the activities in our region, and use it as an opprtunity to create awareness around health and safety.

Sister Nancy Johnson has attended the Saskatoon District Labour Councils event over the last four years and this year she was asked to give a speech and greetings on behalf of the SFL President and Executive Council. The speech included the recognition of the hard work of PSAC member Howard Willems, family and friends in the success of the newly enacted bill, "Howard's Law" making it mandatory to report all absestos in public buildings. Labour activists all across Saskatchewan celebrated this monumental bill. PRC member Sister Jackie Nettleton laid a wreath on behalf of the PSAC Saskatoon Area Council.

### Website and E-newsletter Submissions

One of the main goals of the committee is to create awareness around health and safety issues. One way the committee decided was a valuable tool was the e-newsletter that is sent to members throughout the prairies periodically. The other is by posting relevant H&S information on the PSAC Prairiesries website, for the membership to have access to celebrated

To date, the committee has created several different communications, including topics such as; an introduction to the committee, including its roles and functions, and highlighting some of the successes of the PSAC in regards to health and safety.

### **National Health and Safety Conference**

This event, held April 11-14, 2013 in Montreal, gave the opportunity for the committee members to interact with other H&S activists, hear from some motivating and inspirational speakers, and attend workshops. It was also opportunity for the committee members to host a discussion with H&S activists from the prairies, to discuss the goals and needs of the region, as well as setting up a plan moving forward, capitalizing on the National and Prairie Regional Health and Safety conferences.

### **Health and Safety Education**

A new, introductory course was created in the region, titled "Health and Safety in PSAC Workplaces". The committee was able to work with the Regional Education Officer, Judy Shannon, and shape the outlook of the course, based on feedback and information the committee members had received from members, particularly from the session at the national conference.

Committee member Johnson has co-facilitated at the SFL OH&S conference, the Act and Regulations workshop the last 2 years. At the PSAC's VP to SFL, at the 2013 convention candle lighting ceremony, she lit a candle on behalf of PSAC H&S activist Howard Willems, who passed away in November 2012 of mesothelioma. She haa increased her knowledge of OH&S issues by enrolling in courses and plans to write the exam to be a Canadian Registered Safety Professional. The Saskatoon RWC and Area Council committees renamed the Saskatoon Regional office boardroom after Howard, citing that he spent many years in that room, planning, mentoring and discussing issues of the day with young activists. A photo and plaque was unveiled at their December 2013 Open House.

We would like to thank the members who sit on their local, regional and national health and safety committees or councils. This important work wouldn't be done without you!

### **Budget Assumptions:**

- 1) AEC Transfer may change after the 2015 PSAC Triennial Convention
- 2) The Budget amounts for these expenditures will be available for use by the PRC at any time over the three year period

As we move to the next budget cycle, this budget is being presented to continue regional support for PSAC's priorities of:

- 1. Defending collective agreements
- 2. Defending public services
- 3. Building opposition to the federal Conservative government

This budget provides the resources for members at all levels to participate in their union and mobilize around issues for all workers. It is about communicating with members using new and proven technologies. It is about providing resources and support for Prairie Region Council members to illustrate leadership within their constituencies. It is about working collectively with components and National Officers to build momentum. And it's about providing opportunities for members to network both within the membership and with others in the labour movement and allies in the community.

Anticipating a critical time of action leading into the next budget cycle, expenses from 2012-2014 were monitored closely with many line items significantly under budget. As we move forward, reallocating these funds may assist in achieving our priorities.

### **Meetings**

The PRC holds a minimum of two face-to-face meetings per year. The budget line item of \$78,600 has not been increased from 2012-2014 and covers the costs of LWOP, travel, accommodations and meeting room costs. Our committee work will continue to be covered by this line item.

### **Conference Calls**

This is a new line item of \$5,000 for the 2015-2017 budget. In the past, conference calls with PRC and/or National Officers have been covered under the PRC Meetings line item. Members in the region have clearly identified communication as a priority and as such, starting in December 2012, the PRC has held monthly update conference calls at a regularly scheduled time (excluding July and August). This ensures that PRC reps have access to timely information to report back to their constituents. Costs for the monthly update calls, official PRC conference calls and committee conference calls (as needed) were charged to the PRC Meeting line item and totalled \$2,789.82 for 2013. The

budgeted amount includes for up to 10 monthly update calls as well as additional official conference calls where decision-making is required.

It was also identified that National Officers of components are critical to our success in mobilizing members in the region. Several conference calls have been held with the REVP and National Officers to not only provide information but get feedback on how to achieve our priorities. The budgeted amount includes for up to four conference calls per year with National Officers.

### **Council Members**

The line item for Council members has not changed from the previous amount of \$10,000. The members continue to do their outreach via email, phone and face-to-face meetings. While we remain under budget, it is prudent to keep the line item the same as we look at PRC members doing outreach to all locals urban and rural. Of the \$5,362.40 expended in 2013, \$3,805.62 was for PRC reps to attend Leadership meetings in April/May 2013.

### **Special Projects**

This line item has not changed from the previous amount of \$5,000. It has been used to support local initiatives. For example, in 2013, the full allotment was contributed to the PSAC Social Justice Fund for relief efforts in the Southern Alberta region affected by flooding.

### **Donations**

This line item has not changed from the previous amount of \$5,000. Donations have been in support of Brothers and Sisters from PSAC locals and within the labour movement who have been on extended strikes, donations to local advocacy groups or charities such as Unemployed Workers Centres and Labour Day events.

### **Equity Events**

This line item has been reduced by \$1,000 to \$5,000 from \$6,000. While it has been underutilized, it is prudent to keep a significant amount and to ensure that members are aware that funding may be available for equity events in their location.

### **RWC Special Events**

This line item has been reduced by \$2,000 to \$10,000 from \$12,000. The reduction reflects the change in status for the Prince Albert and Westman RWC's which are inactive. The 2012-2014 budget allocated \$12,000 per year for Regional Womens Committees to fund one-day seminars in their respective locations. This line item has been reduced to \$10,000 per year from \$12,000. While the funds have not been expended in 2012-2013, it is a practice some RWC's are planning for.

### **Human Rights Committee Assistance**

This line item has not changed from the previous amount of \$5,000. We have four active HRC's in Edmonton, Calgary, Regina and Winnipeg, as well as an active RAPC in Prince Albert. Full reports of the HRC activities can be found in our Convention documents. Although these committees receive some funding from Ottawa, our work within our communities and workplaces on equity issues and to fight the governments (federal, provincial and municipal) on regressive agendas, must continue.

Changes to the allocation process, initiated in 2012, included committees receiving funds based on action plans and budgets and the actual bank balance already available versus an equal division between active committees. PRC reviewed all requests for funding and approved allocations based on the information provided. All funds remaining in this line item will continue to be available for use by HRC's upon request.

### Regional Women's Committee Assistance

This line item has been reduced by \$1,000 to \$5,000 from \$6,000. We have six active RWC's in Edmonton, Calgary, Lethbridge, Saskatoon, Regina, and Winnipeg. RWC's in Prince Albert and Westman are currently inactive. Full reports of the RWC activities can be found in our Convention documents. Although these committees receive some funding from Ottawa, our work within our communities and workplaces on womens issues and to fight the governments (federal, provincial and municipal) on regressive agendas, must continue.

Changes to the allocation process, initiated in 2012, included committees receiving funds based on action plans and budgets and the actual bank balance already available versus an equal division between active committees. PRC reviewed all requests for funding and approved allocations based on the information provided. All funds remaining in this line item will continue to be available for use by RWC's upon request.

### Area Council Assistance

This line item has been reduced by \$2,000 to \$10,000 from \$12,000. We have eight active AC's in Edmonton, Calgary, Lethbridge, Prince Albert, Saskatoon, Regina, Westman and Winnipeg. Full reports of the Area Council activities can be found in our Convention documents. The Area Councils are mandated to serve as a liaison for Locals/Branches of Components and Directly Chartered Locals. This line item is to assist them with meetings, education, speakers and community events as most political action expenses incurred are charged to the Political Action budget.

Changes to the allocation process, initiated in 2012, included committees receiving funds based on action plans and budgets and the actual bank balance

already available versus an equal division between active committees. PRC reviewed all requests for funding and approved allocations based on the information provided. All funds remaining in this line item will continue to be available for use by Area Council's upon request.

### Committee/Council Networking

This is a new line item for 2015-2017 for \$2,500 per year. Committees and Area Councils provide opportunities for members to participate at the grassroots level. While Committees and Area Councils may read each others minutes, this line item will ensure that Committees and Area Councils have an opportunity to meet via conference call or webinar a minimum of twice per year to share successes and challenges.

### Federations of Labour

In the last budget cycle, the line item for Federations of Labour was separated for each province to accurately reflect the needs of our region. We believe that members need to take an active part in the labour movement as a whole and the best way to do that is through the Federations of Labour. PSAC pays the affiliation fees for our Locals but does not cover the cost of Conventions or Conferences. This line item will ensure we are able to offer members subsidies to participate within their respective Federation of Labour.

# Youth Camp – Manitoba, Saskatchewan and Alberta (Mary Veilleux Memorial)

Last budget cycle, funding for Youth Camps was separated into individual line items. This line item has been moderately reduced based on usage to \$1,500 from \$2,000 per year, per province. We have historically funded at least one child to our respective Federation of Labour Kids Camps and had to find monies within other line items until last budget cycle. Although not fully utilized in each province, reports back from those attending are that it is an experience of a lifetime. While the attendees may not end up as PSAC members, they go home understanding what unions are and how they contribute to society. This line item is also available to assist members to participate as camp counselors.

### Young Worker Outreach

This line item (formerly called Youth Outreach) has not been changed from the previous budget amount. Due to a change for the PRC Young Worker representative in 2012, plans for young worker outreach was re-scheduled to 2013. This line item has also been used to assist young workers to attend local conferences such as Federation of Labour Young Worker conferences. As the network increases, it is important that we have resources available to support young workers.

### Convention

The Prairie Region Convention is not fully funded irrespective of the money allocated in the PSAC budget. As such, we continue to believe it is prudent to maintain this line item. Our practice has been to use all monies received from the PSAC's budget on subsidies for our members and any surplus from the Council and registration fees on the costs of doing business at Convention. This line item will ensure that, at least in part, these costs would be covered should there be an occasion where there is no surplus to draw from.

### Memberships

This is a new line item that will be used to cover annual membership to Canadian Centre for Policy Alternatives in Manitoba and Saskatchewan and Public Interest Alberta. Both CCPA and PIA, provide valuable research and educational resources on issues of a provincial and federal nature. They are non-profit organizations that rely on funding from progressive organizations such as unions to operate and this line item would ensure we could make a commitment each year. As members of these organizations, PSAC members often receive a discount on attending events.

#### Communications

This was a new line item from the 2012-2014 budget has been reduced by \$2,000 to \$13,000 from \$15,000. It was initially intended to do a hard copy newsletter from the region twice per year that would be mailed to the membership. Following a Communications survey done at the 2012 Prairie Region Convention, attendees indicated that they preferred electronic forms of communications versus hard copies sent by mail. As such, the budget was used to purchase banners for each Regional Office to use at union or community and regional swag and promotional items with the new logo.

This line item will be used to support a variety of communication strategies including but not limited to, purchasing promotional materials, the e-newsletter, new forms of technologies that may become available to create networking such as exploring a Prairie Region webinar license, media advertising, etc.
