CALL FOR NOMINATIONS

Delegates of the PSAC Prairie Region Triennial Convention will elect a Regional Executive Vice-President (REVP) and an Alternate Executive Vice-President to serve a three-year term.

Nominations: Eligibility for Office

- Nominations open effective April 29, 2011
- PSAC members in good standing who live or work in the Prairie Region are eligible for nominations to these elected positions.
- PSAC members are not required to be Convention Delegates to be nominated for these elected positions.
- Nominations shall be in writing, signed by a nominator and a seconder, each of whom must be accredited delegates at the 2011 convention.

Nomination Deadline:

- Nominations from PSAC Prairie Region Triennial Convention delegates will be accepted (1) if received by mail or fax by the Regional Coordinator-Prairies (Patricia Davis) at the Winnipeg Regional Office prior to the start of convention and **no later than June 8, 2011 at 5:00 pm.**
- Nominations from members in good standing that are not delegates at the 2011 Prairie Regional Triennial Convention must be received by fax or mail by the Regional Coordinator-Prairies (Patricia Davis) at the Winnipeg Regional Office prior to the start of Regional Convention and **no later than June 8, 2011 at 5:00 pm.**
- Nominees who will be present at Convention can submit a nomination form to the Nominations Committee prior to the start of the Regional Convention, or be nominated from the floor of the Prairie Region Triennial Convention.

Nominees Address to Convention Delegates:

- Candidates will be invited to address the Convention Delegates on June 11, 2011 for a maximum of three minutes in the reverse order of nomination.



- Candidates not attending the PSAC Prairie 5th Triennial Convention can have a delegate speak on their behalf, or are invited to submit a written statement in advance of the elections that can be read by a member of the Nominations Committee.

Submitting the Nomination Form:

You will find attached a Nomination Form for the position of Regional Executive Vic-President and Alternate Regional Executive Vice-President.

Election Process

A Nominations Committee will be appointed by the Prairie Region Council and ratified on the Convention floor. The Chairperson of the Nominations Committee is also appointed by the Regional Council and either they or the ranking PSAC National Officer will conduct the election of REVP and Alternate REVP. The Chairperson has the power to appoint scrutineers and assistants deemed necessary to conduct the elections in an orderly manner.

Also please note that the spending limit on REVP campaigns is \$3600.00 as per Regulation 21 in the PSAC constitution.
